During the period under review, Council members held a videoconference in connection with the item entitled "Non-proliferation/Democratic People's Republic of Korea" to announce the adoption of a resolution under Chapter VII of the Charter. More information on the videoconference is given in the table below. In addition, Council members held consultations of the whole and closed videoconferences in connection with the item. 1073

On 26 March, the Council unanimously adopted resolution 2569 (2021), by which it extended the

mandate of the Panel of Experts established pursuant to resolution 1874 (2009) in support of the Committee established pursuant to resolution 1718 (2006), for a period of 12 months, until 30 April 2022. The Council requested the Panel to provide periodic reports and expressed its intent to review the Panel's mandate and to take appropriate action regarding a further extension no later than 25 March 2022, as well as to continue to follow the work of the Panel. The Council also underscored that the Panel would carry out credible, fact-based, independent assessments, analyses and recommendations in an objective and impartial manner and in accordance with its mandate. 1074
