The fact that a matter is or is not included in the forecast carries no implication that it will or will not be taken up during the month: the actual programme of work will be determined by developments and the views of members of the Council.

TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF MAY 2011

AFRICA

Burundi – BNUB

Resolution 1959 (2010) 16 December 2010

Para. 15: requests the Secretary-General to keep the Council informed every 6 months on the implementation of the mandate of the United Nations Office in Burundi (BNUB) and this resolution, with a briefing by 31 May 2011, and calls upon the Secretary-General to develop a set of benchmarks for the future evolution of BNUB into a United Nations Country Team presence and regularly report on their progress to the Security Council.

The briefing on behalf of the Secretary-General is expected to be given by 31 May 2011.

Central African Republic – BINUCA

S/PRST/2001/25 of 26 September 2001

Last para.: requests the Secretary-General to continue to keep the Security Council <u>regularly</u> <u>informed</u> on the situation in the Central African Republic.

The report of the Secretary-General is expected to be issued by 31 May 2011.

CAR, Chad and subregion – post-MINURCAT report

S/PRST/2010/29 of 20 December 2010

Sixth para.: requests the Secretary-General to report by the conclusion of the liquidation phase of the United Nations Mission in the Central African Republic and in Chad (MINURCAT) <u>on</u> <u>30 April 2011</u> on the progress made in eastern Chad on the protection of civilians, especially women and children, including (i) the status of refugees and internally displaced persons and durable solutions to their displacement, (ii) unimpeded, safe and timely humanitarian access, including the movement and security of humanitarian personnel and the delivery of humanitarian aid, (iii) on the measures taken to respond to violations of humanitarian, human rights and refugee law, and (iv) the overall security situation as it affects the humanitarian situation.

The report of the Secretary-General dated 29 April 2011 (S/2011/278) is before the Security Council.

Côte d'Ivoire – UNOCI

Resolution 1968 (2011) of 16 February 2011

Para. 1: decides to authorize the Secretary-General, further to paragraphs 3 and 4 of resolution 1967 (2011), paragraph 6 of resolution 1962 (2010), resolution 1951 (2010) and paragraphs 4 and 6 of resolution 1609 (2005), to extend <u>up to 3 months</u> the temporary

redeployment from the United Nations Mission in Liberia (UNMIL) to the United Nations Operation in Côte d'Ivoire (UNOCI) of three infantry companies, one aviation unit comprised of two military utility helicopters and three armed helicopters with crews.

The authorization for the temporary redeployment will expire on 16 May 2011.

Democratic Republic of the Congo - MONUSCO

Resolution 1925 (2010) of 28 May 2010

Para. 7: decides to keep under continuous review the strength of the United Nations Organization Stabilization Mission in the Democratic Republic of the Congo (MONUSCO) on the basis of assessments from the Secretary-General and the Government of the Democratic Republic of the Congo as provided to the Secretary-General on progress towards the implementation of the objectives presented in paragraph 6 of this resolution and to that end requests the Secretary-General to report regularly on these assessments to the Security Council, through the reports mentioned in paragraph 20 of this resolution, to enable the Council to make informed decisions and seize opportunities for reconfiguration.

Para. 20: requests the Secretary-General to report <u>by 13 May 2011</u> on the progress on the ground, in particular in light of the assessment discussions with the Congolese authorities mentioned in paragraph 7 of this resolution, and on the implementation of this resolution with a view to progressively adapting the United Nations presence in the Democratic Republic of the Congo, and recalling the statement of its President of 5 August 2009 (PRST/2009/24), requests the Secretary-General to provide in his reports an indication of progress towards achieving a coordinated United Nations approach in-country, and in particular on critical gaps to achieving peacebuilding objectives alongside the mission.

Para. 22: requests the Secretary-General to elaborate the concept of operation and rules of engagement of MONUSCO in line with the provisions of this resolution and to report on this to the Security Council and troop-contributing countries.

The report of the Secretary-General is expected to be issued by 13 May 2011.

Democratic Republic of the Congo – Group of Experts

<u>Resolution 1952 (2010) of 29 November 2010</u> Para, 5: requests the Group of Experts to report to the Security Counc

Para. 5: requests the Group of Experts to report to the Security Council in writing, through the Committee established pursuant to resolution 1533 (2004), by 18 May 2011.

The report of the Group of Experts is expected to be submitted by 18 May 2011.

Libyan Arab Jamahiriya – resolution 1973 (2011)

Resolution 1973 (2011) of 17 March 2011

Para. 12: requests the Secretary-General to report to the Security Council within 7 days and <u>every month</u> thereafter on the implementation of this resolution, including information on any violations of the flight ban imposed by paragraph 6 of this resolution.

The Secretary-General is expected to report to the Security Council during May 2011.

Libyan Arab Jamahiriya – International Criminal Court

Resolution 1970 (2011) of 26 February 2011

Para. 4: decides to refer the situation in the Libyan Arab Jamahiriya since 15 February 2011 to the Prosecutor of the International Criminal Court (ICC).

Para. 7: invites the ICC Prosecutor to address the Security Council <u>within 2 months</u> of the adoption of this resolution on actions taken pursuant to this resolution.

The ICC Prosecutor is expected to brief the Security Council in early May 2011.

Somalia – peacebuilding and peacemaking

Resolution 1964 (2010) of 22 December 2010

Para. 20: requests the Secretary-General to report on all aspects of this resolution <u>every 4</u> <u>months</u> commencing 1 January 2011 and expresses its intention to review the situation, as part of the reporting obligations of the Secretary-General, as specified in the statement by the President of the Security Council of 31 October 2001 (S/PRST/2001/30) and Security Council resolutions 1863 (2009), 1872 (2009) and 1910 (2010).

The report of the Secretary-General dated 28 April 2011 (S/2011/277) is before the Security Council.

The Sudan – UNMIS

Resolution 1978 (2011) of 27 April 2011

Para.1: decides to extend until 9 July 2011 the mandate of the United Nations Mission in the Sudan (UNMIS) as set out in resolution 1590 (2005).

Para. 2: announces the intent of the Security Council to establish a mission to succeed UNMIS.

Para. 3: requests the Secretary-General to continue to consult with the Comprehensive Peace Agreement parties in this regard and to submit a report <u>by 16 May 2011</u>.

The report of the Secretary-General is expected to be issued by 16 May 2011.

ASIA

Iraq – DFI / IAMB and immunity provisions

Resolution 1956 (2010) of 15 December 2010

Para. 4: requests that the Government of Iraq provide a written report to the Security Council <u>no later than 1 May 2011</u> on progress towards the transition to a post-Development Fund mechanism.

The report of the Government of Iraq is expected to be issued by 1 May 2011.

The situation in the Middle East, including the Palestinian Question

Resolution 1322 (2000) of 7 October 2000

Para. 7: invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

EUROPE

Bosnia and Herzegovina – report of the High Representative

Resolution 1948 (2010) of 18 November 2010

Para. 21: requests the Secretary-General to continue to submit to the Security Council reports from the High Representative, in accordance with Annex 10 of the Peace Agreement and the conclusions of the Peace Implementation Conference held in London on 4 and 5 December 1996 (S/1996/1012) and later Peace Implementation Conferences, on the implementation of the Peace Agreement, and in particular on compliance by the parties with their commitments under that Agreement.

The report of the High Representative is expected to be issued during May 2011.

Resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) – UNMIK Resolution 1244 (1999) of 10 June 1999

Para. 20: requests the Secretary-General to report to the Security Council <u>at regular</u> intervals on the implementation of the resolution.

The report of the Secretary-General is expected to be issued in early May 2011.

OTHER

Children and armed conflict

S/PRST/2010/10 of 16 June 2010

Last para.: requests the Secretary-General to submit a report by May 2011 on the implementation of its resolutions and Presidential statements on children and armed conflict, including the present statement.

The report of the Secretary-General is expected to be issued in early May 2011.

Coordinated reporting by Chairmen of counter- terrorism committees Resolution 1904 (2009) of 17 December 2009

Para. 46: requests the Committee established pursuant to resolution 1267 (1999) concerning Al-Qaida and the Taliban and associated individuals and entities to report orally, through its Chairman, to the Security Council <u>at least every 180 days</u> on the state of

the overall work of the Committee and the Analytical Support and Sanctions Monitoring Team and, as appropriate, in conjunction with the reports by the Chairmen of the Committee established pursuant to resolution 1373 (2001) (Counter-Terrorism Committee (CTC)) and of the Committee established pursuant to resolution 1540 (2004).

Resolution 1963 (2010) of 20 December 2010

Para. 14: requests the CTC to report orally, through its Chairman, at least <u>every 180 days</u> to the Security Council on the overall work of the CTC and the Counter-Terrorism Committee Executive Directorate (CTED), and, as appropriate, in conjunction with the reports by the Chairmen of the Committee established pursuant to resolution 1267 (1999) and the Committee established pursuant to resolution 1540 (2004).

The Chairmen of the three counter-terrorism committees are expected to give a joint briefing to the Security Council <u>during May 2011</u>.

Non-proliferation (Iran) – Panel of Experts

Resolution 1929 (2010) of 9 June 2010

Para. 29: decides that the Panel of Experts shall provide to the Security Council a final report no later than <u>30 days prior to the termination of its mandate</u> with its findings and recommendations.

The final report of the Panel of Experts is expected to be submitted by 9 May 2011.

Non-proliferation / DPRK

<u>Resolution 1928 (2010) of 7 June 2010</u> Para. 2: requests the Panel of Experts to provide to the Security Council <u>no later than 30</u> <u>days prior to the termination of its mandate</u> a final report with its findings and recommendations.

The report of the Panel of Experts is expected to be submitted to the Security Council by <u>12 May 2011</u>.

Resolution 1718 (2006) of 14 October 2006

Para. 12(g): decides that the Committee established pursuant to resolution 1718 (2006) shall report <u>at least every 90 days</u> to the Security Council on its work, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraph 8 of this resolution.

The Chairman of the 1718 Committee is expected to report to the Security Council <u>during</u> <u>May 2011</u>.

Protection of civilians in armed conflict

<u>S/PRST/2002/41 of 20 December 2002</u> Last para.: welcomes the oral briefings to be given to the Security Council <u>every 6 months</u>.

The next oral briefing is expected to be given during May 2011.

Post-conflict peacebuilding – review of international civilian capacities S/PRST/2011/2 of 21 January 2011

Last para.: states that the Security Council looks forward to the report of the international review of civilian capacity in early 2011, recognizing the need for improved mechanisms for timely deployment of skilled civilian experts in support of national institution building needs in post-conflict countries.

S/PRST/2009/23 of 22 July 2009

Emphasizing the critical importance of post-conflict peacebuilding as the foundation for building sustainable peace and development in the aftermath of conflict, welcomes the recommendation of the Secretary-General for a review to be undertaken to analyse how the United Nations and the international community can help to broaden and deepen the pool of rapidly deployable civilian experts, giving particular attention to mobilising capacities from developing countries and especially women.

Press release PBC/65 of 16 March 2010

Announces the appointment by the Secretary-General of a Senior Advisory Group for the Review of International Civilian Capacities, the overall goal of which is to strengthen the availability, deployability and appropriateness of civilian capacities for peacebuilding.

The Independent report of the Senior Advisory Group on Civilian Capacity in the Aftermath of Conflict, dated 22 February 2011 (S/2011/85), is before the Security Council.

International Day of United Nations Peacekeepers

The International Day of United Nations Peacekeepers will be observed on 27 May 2011.
