TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF DECEMBER 2011

This tentative forecast of the programme of work of the Security Council has been prepared by the Secretariat for the President of the Council. The forecast covers in particular those matters that may be taken up during the month pursuant to earlier decisions of the Council. The fact that a matter is or is not included in the forecast carries no implication that it will or will not be taken up during the month: the actual programme of work will be determined by developments and the views of members of the Council.

Preliminary forecast for December 2011

AFRICA

Burundi – BNUB

Resolution 1959 (2010) 16 December 2010

Para. 1: requests the Secretary-General to establish the United Nations Office in Burundi (BNUB), as recommended in his report (S/2010/608), as a significantly scaled-down United Nations presence, for an <u>initial period of 12 months</u> beginning on 1 January 2011, to support the progress achieved in recent years by all national stakeholders in consolidating peace, democracy and development in Burundi.

The BNUB mandate will expire on 31 December 2011.

Para. 15: requests the Secretary-General to keep the Council informed every 6 months on the implementation of the mandate of BNUB and this resolution, with a report <u>by 30 November</u> <u>2011</u>, and calls upon the Secretary-General to develop a set of benchmarks for the future evolution of BNUB into a United Nations Country Team presence and <u>regularly report</u> on their progress to the Security Council.

The report of the Secretary-General dated 30 November 2011 (S/2011/751) is before the Security Council.

Central African Republic – BINUCA

<u>S/PRST/2001/25 of 26 September 2001</u> Last para: requests the Secretary-General to continue to keep the Council <u>regularly informed</u> on the situation in the Central African Republic.

The report of the Secretary-General dated 28 November 2011 (S/2011/739) is before the Security Council.

S/PRST/2010/26 of 14 December 2010

Last para: welcomes the extension of the United Nations Integrated Peacebuilding Office in the Central African Republic (BINUCA) for the period of one year up <u>until 31 December 2011.</u>

The BINUCA mandate will expire on 31 December 2011.

Côte d'Ivoire - UNOCI

Resolution 2000 (2011) of 27 July 2011

Parra. 18: Requests the Secretary-General to provide to it a midterm report no later than 31 December 2011 and a final report no later than 30 June 2012 on the situation on the ground and the implementation of this resolution, and further requests the Secretary-General to regularly

brief and inform it on the significant events of the electoral process, including on UNOCI's support to this process;

The report of the Secretary-General is expected to be issued during December 2011.

Guinea-Bissau – UNIOGBIS

Resolution 1949 (2010) of 23 November 2010

Para. 1: decides to extend the mandate of the United Nations Integrated Peacebuilding Office in Guinea-Bissau (UNIOGBIS) <u>until 31 December 2011</u>.

The UNIOGBIS mandate will expire on 31 December 2011.

Para. 3: requests the Secretary-General to develop a strategic workplan with appropriate benchmarks to measure and track progress on the implementation of the UNIOGBIS mandate.

The report of the Secretary-General dated 21 October 2011 (S/2011/655) is before the Security Council.

Liberia – measures on arms and travel

Resolution 1961 (2010) of 17 December 2010

Para. 1: decides to renew the measures on travel imposed by paragraph 4 of resolution 1521 (2003) for a period of 12 months from the date of adoption of this resolution.

The measures on travel will expire on 17 December 2011.

Para. 3: decides to renew for a period of 12 months from the date of adoption of this resolution the measures on arms, previously imposed by paragraph 2 of resolution 1521 (2003) and modified by paragraphs 1 and 2 of resolution 1683 (2006), by paragraph 1(b) of resolution 1731 (2006), and by paragraphs 3, 4, 5 and 6 of resolution 1903 (2009).

The measures on arms will expire on 17 December 2011.

Liberia – measures concerning Charles Taylor and related persons

Resolution 1961 (2010) of 17 December 2010

Para. 4: reconfirms the intention of the Security Council to review the measures imposed by paragraph 1 of resolution 1532 (2004), to prevent former President Charles Taylor, his immediate family members, senior officials of the former Taylor regime, or other close allies or associates from using misappropriated funds and property to interfere in the restoration of peace and stability in Liberia and the subregion, <u>at least once a year</u>.

The measures concerning Charles Taylor and related persons are expected to be reviewed by 17 December 2011.

Liberia – Panel of Experts

Resolution 1961 (2010) of 17 December 2010

Para. 6 (f): decides that the Panel of Experts shall provide a final report to the Security Council, through the Committee established pursuant to resolution 1521 (2003), on the issues listed in paragraphs 6(a) through 6(f) of the resolution by 1 December 2011.

The Panel of Experts is expected to provide its final report by 1 December 2011.

Para. 6: decides to extend the mandate of the Panel of Experts appointed pursuant to paragraph 9 of resolution 1903 (2009) for a further period <u>until 16 December 2011</u>.

The mandate of the Panel of Experts will expire on 16 December 2011.

Libya – UNSMIL

Resolution 2009 of 16 September 2011

Para. 12: decides to establish a United Nations Support Mission in Libya (UNSMIL), under the leadership of a Special Representative of the Secretary-General for an initial period of three months.

The UNSMIL mandate will expire on 16 December 2011.

Para. 22: requests the Secretary-General to report on implementation of this resolution in <u>14</u> days from adoption, and every month thereafter, or more frequently as he sees fit

The Secretary-General is expected to report to the Security Council during December 2011.

Somalia

Resolution 2010 (2011) of 30 September 2011

Para. 29 : requests the Secretary-General to report on all aspects of this resolution <u>every four months</u> and expresses its intention to review the situation, as part of his reporting obligations, as specified in the statement of the President of the Security Council of 31 October 2001 (S/PRST/2001/30) and Security Council resolutions, 1863 (2009), 1872 (2009), 1910 (2010) and 1964 (2010)

The report of the Secretary-General is expected to be issued during December 2011.

Somalia – UNPOS

Letter from the Council President to the Secretary-General of 21 December 2009 (S/2009/665) takes note of the intention of the Secretary-General expressed in his letter dated 15 December 2009 (S/2009/664) to let the United Nations Political Office for Somalia (UNPOS) continue to carry out its tasks <u>during the biennium 2010-2011</u>.

The UNPOS mandated tasks will expire on 31 December 2011.

Somalia – piracy

Resolution 2015 (2011) 24 October 2011

Para. 7: reiterates its request, as a matter of urgency, to the TFG and relevant Somali regional authorities to elaborate, with the assistance of UNODC and UNDP, and adopt a complete set of counter-piracy laws, including laws to prosecute those who illicitly finance, plan, organize, facilitate or profit from pirate attacks, with a view to ensuring the effective prosecution of suspected pirates and those associated with piracy attacks in Somalia, the post-conviction transfer of pirates prosecuted elsewhere to Somalia, and the imprisonment of convicted pirates in Somalia, as soon as possible, and requests the TFG and relevant regional authorities of Somalia to provide a report to the Security Council <u>by 31 December 2011</u> on action taken in each of the areas above;

The TFG report is expected to be issued during December 2011

The Sudan – International Criminal Court

Resolution 1593 (2005) of 31 March 2005

Para. 8: invites the Prosecutor of the International Criminal Court (ICC) to address the Security Council <u>every 6 months</u> on actions taken pursuant to the resolution.

The ICC Prosecutor is expected to brief the Security Council in early December 2011.

The Sudan – Sanctions Committee

<u>Resolution 1591 (2005) of 29 March 2005</u> Para. 3(a)(iv): decides that the Security Council Committee established pursuant to resolution1591 (2005) shall report at least <u>every 90 days</u> to the Security Council on its work.

The Chairman of the 1591 Committee is expected to report to the Security Council in early December 2011.

Sudan - UNISFA

Resolution 1990 (2011) of 27 June 2011

Para. 1: decides to establish, for a <u>period of 6 months</u>, the United Nations Interim Security Force for Abyei (UNISFA), taking into account the Agreement between the Government of Sudan and the Sudan People's Liberation Movement on Temporary Arrangements for the Administration and Security of the Abyei Area, and further decides that UNISFA shall comprise a maximum of 4,200 military personnel, 50 police personnel, and appropriate civilian support;

The UNISFA mandate will expire on 31 December 2011.

Para. 11: requests the Secretary-General to keep the Council regularly informed of the progress in implementing the Agreement and to report to the Council <u>no later than thirty days</u> after the adoption of this resolution and <u>every 60 days thereafter</u>.

The report of the Secretary-General dated 27 November 2011 (S/2011/741) is before the Security Council.

United Nations Office for West Africa (UNOWA)

Letter from the President of the Security Council dated 20 December 2010 (S/2010/661) Requests that the Secretary-General report to the Security Council <u>every 6 months</u> on the fulfilment by the United Nations Office for West Africa (UNOWA) of its revised mandate.

The report of the Secretary-General is expected to be issued during December 2011.

ASIA

Afghanistan - Implications for international peace and security Resolution 1974 (2011) of 22 March 2011

Para. 42: requests that the Secretary-General reports to the Council every three months on developments in Afghanistan, and to include in his reports an evaluation of progress made against the benchmarks for measuring and tracking progress in the implementation of UNAMA's mandate and priorities as set out in this resolution.

Para. 43: further requests that the Secretary-General conduct a comprehensive review of UNAMA's mandated activities and the United Nations' support in Afghanistan, including UNAMA's presence throughout the country, in consultation with the Afghan Government and relevant international stakeholders, by the end of 2011, with the aim of strengthening national ownership and leadership consistent with the Kabul Process, taking into account the evolving nature of the international community's presence and the role of ISAF, and including first experiences with the Transition (Integal), with a view to informing the Council's review of UNAMA's mandate in March 2012.

The report of the Secretary-General is expected to be issued by mid-December 2011.

Iraq – UNAMI

<u>Resolution 2001 (2011) of 28 July 2011</u> Para. 6: Requests the Secretary-General to report to the Council <u>every four months</u> on the progress made towards the fulfilment of all UNAMI's responsibilities.

The report of the Secretary-General dated 28 November 2011 (S/2011/736) is before the Security Council.

Iraq - Development Fund for Iraq Resolution 1956 (2010) of 15 December 2010

Para. 6: requests the Secretary-General to provide written reports on an ongoing basis to the council every six months, with the first report due no later than 1 January 2012, about the United Nations compensation fund, evaluating the continued compliance with the provisions of paragraph 21 of resolution 1483 (2003).

The report of the Secretary-General is expected to be issued during December 2011

Iraq/Kuwait – missing persons and return of property

Letter from the Council President to the Secretary-General of 30 June 2006 (S/2006/469) Takes note of the intention of the Secretary-General in his letter dated 28 June 2006 (S/2006/468) to report, pursuant to resolution 1284 (1999), on compliance by Iraq with its obligations regarding the repatriation or return of all Kuwaiti and third-country nationals or their remains and on the return of all Kuwaiti property <u>every 6 months</u>.

Letter from the Council President to the Secretary-General of 29 July 2011 (S/2011/478) Informs the Secretary-General that the Security Council has decided to earmark \$214,600 from the operating reserves and the fund balance of the escrow account intended for administrative and operational costs to finance the continuation of the activities of the High-level Coordinator and his support staff until 31 December 2011.

The financial arrangements for the activities of the High-level Coordinator will expire <u>on</u> <u>31 December 2011</u>.

The situation in the Middle East, including the Palestinian question Resolution 1322 (2000) of 7 October 2000

Para. 7: invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

Middle East – UNDOF

<u>Resolution 1994 (2011) of 30 June 2011</u> Para. 5: decides to renew the mandate of the United Nations Disengagement Observer Force (UNDOF) <u>until 31 December 2011</u>.

The UNDOF mandate will expire on 31 December 2011.

Para. 6: requests the <u>Secretary-General</u> to submit, <u>at the end of this period, a report</u> on developments in the situation and the measures taken to implement resolution 338 (1973), including an assessment, with recommendations if any, of the operational capacity of UNDOF to ensure the Force is most appropriately configured to fulfil its mandated tasks.

The report of the Secretary-General dated 30 November 2011 (S/2011/748) is before the Security Council.

A meeting between the Security Council and the troop-contributing countries will take place before the expiry of the UNDOF mandate.

EUROPE

Cyprus – UNFICYP

Resolution 1986 of 13 June 2011

Para. 7: decides to extend the mandate of the United Nations Peacekeeping Force in Cyprus (UNFICYP) for a further period ending 15 December 2011.

The UNFICYP mandate will expire on 15 December 2011.

A meeting between the Security Council and the troop- and police-contributing countries will take place before the expiry of the UNFICYP mandate.

Para. 11. requests the Secretary-General to submit a report on implementation of this resolution, including on contingency planning in relation to the settlement, by 1 December 2011.

The report of the Secretary-General dated 30 November 2011 (S/2011/746) is before the Security Council.

OTHER

Non-proliferation (Iran)

Resolution 1737 (2006) of 23 December 2006

Para. 18(h): decides that the Committee established pursuant to resolution 1737 (2006) shall report <u>at least every 90 days</u> to the Security Council on its work and on the implementation of the resolution, with its observations and recommendations.

The Chairman of the 1737 Committee is expected to report to the Security Council <u>during</u> <u>December 2011</u>.

Non-proliferation (Iran) - Panel of Experts Resolution 1984 of 09 June 2011

Para. 2. Requests the Panel of Experts to provide to the Committee no later than 9 November 2011 a midterm report on its work, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its <u>midterm report by 9 December 2011</u>, and requests also a final report to the Committee no later than thirty days prior to the termination of its mandate with its findings and recommendations, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its final report upon termination of the Panel's mandate.

The Panel of Experts is expected to submit its midterm report by <u>9 December 2011</u>.

Non-proliferation/DPRK

Resolution 1985 (2011) of 09 June 2011

Para. 2: Requests the Panel of Experts to provide to the Committee no later than 12 November 2011 a midterm report of its work, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its midterm report <u>by 12 December 2011</u>, and requests also a final report to the Committee no later than thirty days prior to the termination of its mandate with its findings and recommendations, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its final report upon termination of the Panel's mandate.

The Panel of Experts is expected to submit its midterm report by <u>12 December 2011</u>.

ICTY/ICTR – annual reports and completion strategy assessments Art. 34 of the ICTY Statute (S/25704 and Corr.1, annex); Art. 32 of the ICTR Statute (SCR 955 (1994), annex) The Presidents of the International Tribunal for the Former Yugoslavia (ICTY) and of the International Criminal Tribunal for Rwanda (ICTR) shall each submit an <u>annual report</u> to the Security Council and to the General Assembly.

Resolution 1534 (2004) of 26 March 2004

Para. 6: requests the ICTY and the ICTR to provide to the Security Council <u>every 6 months</u> assessments by each President and Prosecutor setting out the progress made towards implementation of the Completion Strategy of the Tribunal, and expresses the intention of the Security Council to meet with the President and Prosecutor of each Tribunal to discuss these assessments.

The Security Council is expected to consider the ICTY annual report (S/2011/473) and completion strategy assessment (S/2011/716) and the ICTR annual report (S/2011/472) and completion strategy assessment (S/2011/731) <u>during December 2011</u>.

International Criminal Tribunal for Rwanda -- Judges

Resolution 1955 (2010) of 14 December 2010

Para. 3: decides that in order for the International Criminal Tribunal for Rwanda (ICTR) to complete existing trials or conduct additional trials, the total number of ad litem Judges serving at the International Tribunal may from time to time temporarily exceed the maximum of nine provided for in article 11, paragraph 1, of the Statute of the International Tribunal, to a maximum of twelve at any one time, returning to a maximum of nine <u>by 31 December 2011</u>.

The authorization temporarily to exceed the number of ad litem judges serving at the ICTR as provided for by the ICTR Statute will expire on 31 December 2011.

Resolution 1932 (2010) of 29 June 2010

Para. 4: decides to extend the term of office of the following <u>permanent judges</u> at the International Tribunal, who are members of the Trial Chamber, <u>until 31 December 2011</u> or until the completion of the cases to which they are assigned, if sooner:

Counter-terrorism – CTED

Resolution 1963 (2010) of 20 December 2010

Para. 13: directs the Counter-Terrorism Committee Executive Directorate (CTED) to produce a Global Implementation Survey of resolution 1624 (2005) by 31 December 2011.

The Global Implementation Survey is to be produced by 31 December 2011.

Letter from the President of the Security Council dated 23 December 2010 (S/2009/665) Informs the Secretary-General that the members of the Security Council have taken note of the intention conveyed by his letter of 20 December 2010 (S/2010/664) to extend the appointment of Mr. Mike Smith as Executive Director of the Counter-Terrorism Committee Executive Directorate (CTED) <u>through 31 December 2011</u>.

The appointment of Mr. Mike Smith as CTED Executive Director will expire <u>on 31 December</u> <u>2011</u>.

Briefing by outgoing chairmen of Security Council subsidiary bodies

The outgoing chairmen of Security Council sanctions committees, counter-terrorism committees and working groups are expected to brief the Council <u>during December 2011</u>.

Ad Hoc Working Group on Conflict Prevention and Resolution in Africa

Note by the President of the Security Council dated 21 December 2010 (S/2010/654) States that it has been agreed by members of the Security Council that the Ad Hoc Working Group on Conflict Prevention and Resolution in Africa will continue its work <u>until 31 December</u> 2011.

The mandate of the Ad Hoc Working Group will expire on 31 December 2011.

Cameroon-Nigeria Mixed Commission

Letter from the President of the Security Council dated 20 December 2010 (S/2010/638) Informs the Secretary-General that the members of the Security Council have taken note of his letter dated 7 December 2010 (S/2010/637) concerning his intention to continue the activities of the United Nations support team to the Cameroon-Nigeria Mixed Commission, with funding from the regular budget for the period from 1 January to 31 December 2011.

The funding arrangements for the Cameroon-Nigeria Mixed Commission will expire <u>on</u> <u>31 December 2011</u>.
