The fact that a matter is or is not included in the forecast carries no implication that it will or will not be taken up during the month: the actual programme of work will be determined by developments and the views of members of the Council.

## TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF JUNE 2012

## AFRICA

## Central African Region (UNOCA/LRA)

S/PRST/2011/21 of 14 November 2011

Last para: the Security Council requests that the Secretary-General keep it informed on developments in relation to the LRA, including through <u>a single report on both UNOCA and the LRA</u> to be submitted <u>before 31 May 2012</u> identifying opportunities for improved information sharing between the AU, LRA-affected states and UN missions, and outlining the role of UNOCA in co-coordinating activity against the LRA.

The report of the Secretary-General dated xx May 2012 (S/2012/xx) is before the Security Council.

Letter from the President of the Security Council dated 30 August 2010 (S/2010/457) Proposed that the office be established for an initial period of two years, with a <u>review of its</u> mandate after 18 months.

## Central African Republic – BINUCA

S/PRST/2001/25 of 26 September 2001

Last para.: requests the Secretary-General to continue to keep the Security Council <u>regularly</u> <u>informed</u> on the situation in the Central African Republic.

The report of the Secretary-General dated 29 May 2012 (S/2012/374) is before the Security Council.

#### Côte d'Ivoire – UNOCI

Resolution 2000 (2011) of 27 July 2011

Para. 18: requests the Secretary-General to provide to it a midterm report no later than 31 December 2011 and <u>a final report no later than 30 June 2012</u> on the situation on the ground and the implementation of this resolution, and further requests the Secretary-General to regularly brief and inform it on the significant events of the electoral process, including on UNOCI's support to this process.

The report of the Secretary-General is expected to be issued by 30 June 2012.

#### Democratic Republic of the Congo – MONUSCO

Resolution 1991 (2011) of 28 June 2011

Para. 1: decides to <u>extend until 30 June 2012</u> the mandate of MONUSCO as set out in the Resolution 1925 paragraphs 2, 11 and 12 (a) to (p) and (r) to (t), reaffirms that the protection of civilians must be given priority in decisions about the use of available capacity and resources

and encourages further the use of innovative measures implemented by MONUSCO in the protection of civilians.

The MONUSCO mandate will expire on <u>30 June 2012</u>.

A meeting between the Security Council and the troop- and police-contributing countries will take place before the expiry of the MONUSCO mandate.

Para. 23: requests the Secretary-General to report in October 2011, in January 2012 and by the 23 May 2012 on the progress on the ground, further requests the Secretary-General to regularly brief and inform it on the significant events of the electoral process, including on MONUSCO's support to this process, and to provide a comprehensive assessment of the political, security, humanitarian and human rights environment following the elections, and *requests* the Secretary-General to provide in these reports an indication of progress towards achieving a coordinated United Nations approach in-country, and in particular on critical gaps to achieving peacebuilding objectives alongside the mission.

The report of the Secretary-General dated 23 May 2012 (S/2012/355) is before the Security Council.

## Democratic Republic of the Congo – Group of Experts

Resolution 2021 (2011) of 29 November 2011

Para. 5: requests the Group of Experts to report to the Security Council in writing, through the Committee established pursuant to resolution 1533 (2004), by 18 May 2012.

The Chairman of the 1533 Committee is expected to brief the Council during June 2012.

## Guinea-Bissau - sanctions

Resolution 2048 (2012) of 18 May 2012

Para. 1: demands that the Military Command takes immediate steps to restore and respect constitutional order, including a democratic electoral process, by ensuring that all soldiers return to the barracks, and that members of the "Military Command" relinquish their positions of authority.

Para. 11: requests the Secretary-General to submit to the Council an initial report on the implementation of paragraph 1 above <u>within 15 days</u> of the adoption of this resolution, and regular reports, every 90 days thereafter, on the implementation of all its elements, as well as on the humanitarian situation in Guinea-Bissau.

The report of the Secretary-General is expected to be issued by 2 June 2012.

## Liberia – Panel of Experts

Resolution 2025 (2011) of 14 December 2011

Para. 19 (f): requests the Panel of Experts appointed pursuant to paragraph 9 of resolution 1903 (2009) to provide a midterm report to the Council through the Committee <u>by 1 June 2012</u>.

The Panel of Experts is expected to provide its midterm report by 1 June 2012.

## Liberia - UNMIL

## Resolution 2008 (2011) of 16 September 2011

Para. 15: requests the Secretary-General to keep it regularly informed of the situation on the ground as Liberia enters this next critical phase, and to provide <u>by 30 April 2012</u> a report on the issues addressed in paragraphs 2, 5, and 7, including recommendations for appropriate Security Council action, and expresses an intention to consider these recommendations in a timely manner.

The report of the Secretary-General dated 16 April 2012 (S/2012/230) is before the Security Council.

# Libya – 1970 Committee reporting to SC

### Resolution 1970 (2011) of 26 February 2011

Para. 24: decides to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council (herein "the Committee"), to undertake to following tasks: (e) To report within thirty days to the Security Council on its work for the first report and thereafter to report as deemed necessary by the Committee.

## Libya – UNSMIL

## Resolution 2040 (2012) of 12 March 2012

Para. 15: also requests the Secretary-General to report to the Security Council <u>following the</u> <u>elections of a Constituent Assembly</u> on steps taken by UNSMIL to engage with the new Libyan government in order to ensure that it continues effectively to support Libya's specific needs, with a view to reviewing and adjusting the mandate as necessary.

The Secretary-General is expected to report to the Security Council in June 2012.

# Peace and security in Africa – Somalia/Eritrea sanctions

## Resolution 2023 (2011) of 5 December 2011

Para. 19: requests the Secretary-General to <u>report within 180 days</u> on Eritrea's compliance with the provisions of resolutions 1844 (2008), 1862 (2009), 1907 (2009) and this resolution.

The Secretary-General is expected to report to the Security Council by 5 June 2012.

# Peace and security in Africa – Mali<sup>1</sup>

S/PRST/2012/9 of 4 April 2012

Last para: requests the Secretary-General to update the Security Council, as appropriate, on developments in Mali.

## The Sudan – International Criminal Court

Resolution 1593 (2005) of 31 March 2005

Para. 8: invites the Prosecutor of the International Criminal Court to address the Security Council <u>every 6 months</u> on actions taken pursuant to the resolution.

The ICC Prosecutor is expected to brief the Security Council during June 2012.

# The Sudan – 1591 Sanctions Committee

Resolution 1591 (2005) of 29 March 2005

Para. 3(a)(iv): decides that the Security Council Committee established pursuant to resolution 1591 (2005) shall report at least <u>every 90 days</u> to the Council on its work.

The Chairman of the 1591 Committee is expected to brief the Security Council <u>during June</u> <u>2012</u>.

# The Sudan (Sudan/South Sudan)

Resolution 2046 (2012) of 2 May 2012

Para. 6: requests the Secretary-General to consult with the African Union on the implementation of this resolution and the decisions of the AU PSC, to work closely with the AUHIP in support of its facilitation efforts, and to inform the Security Council within 15 days and <u>in two week intervals</u> thereafter on the status of compliance by Sudan, South Sudan, and the SPLM-N with the decisions set forth in this resolution, and expresses its intention, in the event that any or all of the parties have not complied with the decisions set forth in this resolution, to take appropriate additional measures under Article 41 of the Charter as necessary.

The Secretary-General is expected to report to the Security Council in June 2012.

## Sudan – UNISFA

### Resolution 2047 (2012) of 17 May 2012

Para 15: requests the Secretary-General to continue to inform the Council of progress in implementing UNISFA's mandate in 60 day intervals, and continue to bring to the Council's immediate attention any serious violations of the above referenced agreements.

The report of the Secretary-General dated 24 May 2012 (S/2012/358) is before the Security Council.

## The Sudan – UNMISS

#### Resolution 1996 (2011) of 8 July 2011

Para. 1: decides to establish as of 9 July 2011 the United Nations Mission in the Republic of South Sudan (UNMISS) for an initial period of <u>one year</u> with the intention to renew for further periods as may be required and further decides that UNMISS will consist of up to 7,000 military personnel, including military liaison officers and staff officers, up to 900 civilian police personnel, including as appropriate formed units, and an appropriate civilian component, including technical human rights investigation expertise; and further decides to review in three and six months whether the conditions on the ground could allow a reduction of military personnel to a level of 6,000.

The UNMISS mandate will expire on 9 July 2012.

A meeting between the Security Council and the troop-contributing countries will take place in June.

## United Nations Office for West Africa (UNOWA)

Letter from the President of the Security Council dated 20 December 2010 (S/2010/661) Requests that the Secretary-General report to the Security Council <u>every six months</u> on the fulfilment by the United Nations Office for West Africa (UNOWA) of its revised mandate.

The report of the Secretary-General is expected to be issued during June 2012.

## Afghanistan – UNAMA

## Resolution 2041 (2012) of 22 March 2012

Para. 47: requests that the Secretary-General reports to the Security Council <u>every 3 months</u> on developments in Afghanistan, and to include in his reports an evaluation of progress made against the benchmarks for measuring and tracking progress in the implementation of the mandate and priorities of the United Nations Assistance Mission in Afghanistan (UNAMA)'s mandate and priorities as set out in this resolution.

The report of the Secretary-General is expected to be issued during June 2012.

#### Afghanistan – ISAF

#### Resolution 2011 (2011) of 12 October 2011

Para. 7: requests the leadership of ISAF to keep the Security Council regularly informed, through the United Nations Secretary-General, on the implementation of its mandate, including through the timely provision of <u>quarterly reports</u>.

#### Iraq - Development Fund for Iraq

#### Resolution 1956 (2010) of 15 December 2010

Para. 6: requests the Secretary-General to provide written reports on an ongoing basis to the council every six months, with the first report due no later than 1 January 2012, about the United Nations compensation fund, evaluating the continued compliance with the provisions of paragraph 21 of resolution 1483 (2003).

The report of the Secretary-General is expected to be issued during June 2012

#### Iraq/Kuwait – missing persons and return of property

Letter from the Council President to the Secretary-General of 30 June 2006 (S/2006/469) Takes note of the intention of the Secretary-General in his letter dated 28 June 2006 (S/2006/468) to report, pursuant to resolution 1284 (1999), on compliance by Iraq with its obligations regarding the repatriation or return of all Kuwaiti and third-country nationals or their remains and on the return of all Kuwaiti property <u>every six months</u>.

#### Press statement SC/10490 of 15 December 2011

The members of the Security Council supported the Secretary-General's recommendation to extend the financing of the activities of the High-Level Coordinator for a further period of six months in order to build upon the present momentum towards the full implementation of paragraph 14 of Security Council resolution 1284 (1999).

Letter from the Council President to the Secretary-General of 20 January 2012 (S/2012/52) Informs the Secretary-General that the Security Council has decided to earmark \$245,300 from fund balance of the escrow account created pursuant to Security Council resolution 1958 (2010) to finance the continuation of the activities of the High-level Coordinator and his support staff until 30 June 2012. The financial arrangements for the activities of the High-level Coordinator will expire <u>on 30 June</u> <u>2012</u>.

## The situation in the Middle East, including the Palestinian question

<u>Resolution 1322 (2000) of 7 October 2000</u> Para. 7: invites the Secretary-General to continue to follow the situation and <u>to keep the</u> <u>Security Council informed</u>.

# Middle East – Lebanon (resolution 1701 (2006)

<u>Resolution 2004 (2011) of 30 August 2011</u> Para.10 requests the Secretary-General to continue to report to the Council on the implementation of resolution 1701 (2006), <u>every four months</u>, or at any time as he deems appropriate.

The report of the Secretary-General is expected to be issued by 30 June 2012.

# Middle East – UNDOF

<u>Resolution 2028 (2011) of 21 December 2011</u> Para. 6: decides to renew the mandate of the United Nations Disengagement Observer Force for a period of six months, that is, <u>until 30 June 2012</u>.

The UNDOF mandate will expire on 30 June 2012.

A meeting between the Security Council and the troop-contributing countries will take place before the expiry of the UNDOF mandate.

Para. 7: requests the Secretary-General to submit, <u>at the end of this period, a</u> <u>report</u> on developments in the situation and the measures taken to implement resolution 338 (1973).

The report of the Secretary-General report is expected to be issued during June 2012.

# Middle East – Syria/UNSMIS

Resolution 2043 (2012) of 21 April 2012

Para. 13: requests the Secretary-General to report to the Council on the implementation of this resolution within 15 days of its adoption and every 15 days thereafter, and also to submit, as necessary, to the Council proposals for possible adjustments to the UNSMIS mandate.

The Secretary-General is expected to report to the Security Council in June 2012

## Middle East – Syria

<u>S/PRST/2012/6 of 21 March 2012</u> Last para: requests the Envoy to <u>update the Council regularly</u> and in a timely manner on the progress of his mission. The Envoy is expected to report in June 2012.

# OTHER

## Children and armed conflict

Resolution 1998 (2011) of 12 July 2011

Para. 22: requests the Secretary-General to submit a report by June 2012 on the implementation of its resolutions and presidential statements on children and armed conflict, including the present resolution.

The report of the Secretary-General is expected to be issued in June 2012.

## **CTC/CTED** – Interim review

Resolution 1963 (2010) of 20 December 2010

Para. 2: decides that CTED will continue to operate as a special political mission under the policy guidance of the CTC for the period ending 31 December 2013 and further decides to conduct an <u>interim review by 30 June 2012</u>.

## Non-proliferation (Iran) – 1737 Committee reports

Resolution 1737 (2006) of 23 December 2006

Para. 18(h): decides that the Security Council Committee established pursuant to resolution 1737 (2006) shall report <u>at least every 90 days</u> to the Council on its work and on the implementation of this resolution.

The Chairman of the 1737 Committee is expected to report to the Security Council <u>during June</u> <u>2012</u>.

## Non-proliferation (Iran) – Panel of Experts mandate and reports

Resolution 1984 (2011) of 9 June 2011

Para. 1: decides to extend until 9 June 2012 the mandate of the Panel of Experts, as specified in paragraph 29 of resolution 1929 (2010), and requests the Secretary- General to take the necessary administrative measures to this effect.

The mandate of the Panel of Experts will expire on 9 June 2012.

Para. 2: requests the Panel of Experts to provide to the Committee no later than 9 November 2011 a midterm report on its work, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its midterm report by 9 December 2011, and requests also a final report to the Committee no later than thirty days prior to the termination of its mandate with its findings and recommendations, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its <u>final report</u> upon termination of the Panel's mandate.

The report of the Panel of Experts is before the Security Council.

## Non-proliferation/DPRK

Resolution 1985 (2011) of 10 June 2011

Para. 1: decides to extend until <u>12 June 2012</u> the mandate of the Panel of Experts, as specified in paragraph 26 of resolution 1874 (2009), and requests the Secretary-General to take the necessary administrative measures to this effect.

The mandate of the Panel of Experts will expire on <u>12 June 2012</u>.

Para. 2: requests the Panel of Experts to provide to the Committee no later than 12 November 2011 a midterm report of its work, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its midterm report by 12 December 2011, and requests also a final report to the Committee no later than thirty days prior to the termination of its mandate with its findings and recommendations, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its <u>final report</u> upon termination of the Panel's mandate.

The report of the Panel of Experts is before the Security Council.

## ICTY/ICTR – completion strategies of the tribunals

Resolution 1534 (2004) of 26 March 2004

Para. 6: requests the International Tribunal for the Former Yugoslavia (ICTY) and the International Criminal Tribunal for Rwanda (ICTR) to provide to the Security Council <u>every</u> <u>6 months</u> assessments by each President and Prosecutor with respect to implementation of the Completion Strategy of the Tribunals, and expresses the intention of the Security Council to meet with the President and Prosecutor of each Tribunal to discuss these assessments.

The completion strategy assessments of the ICTY dated 22 May 2012 (S/2012/354) and of the ICTR dated 22 May 2012 (S/2012/349) are before the Security Council.

## ICTR – terms of trial judges

Resolution 2029 (2011) of 21 December 2011

Para. 1: decides to extend the term of office of the following permanent judges at the International Tribunal, who are members of the Trial Chamber, <u>until 30 June 2012</u> or until the completion of the trials to which they are assigned, if sooner:

- Charles Michael Dennis Byron (Saint Kitts and Nevis)
- Khalida Rachid Khan (Pakistan)
- William H. Sekule (United Republic of Tanzania)
- -Bakhtiyar Tuzmukhamedov (Russian Federation).

Para. 2: decides to extend the term of office of the following ad litem judges at the International Tribunal, who are members of the Trial Chamber, <u>until 30 June 2012</u> or until the completion of the trials to which they are assigned, if sooner:

- Florence Rita Arrey (Cameroon)
- Solomy Balungi Bossa (Uganda)
- Robert Fremr (Czech Republic)
- Vagn Joensen (Denmark)
- Gberdao Gustave Kam (Burkina Faso)
- Lee Gacugia Muthoga (Kenya)

- Seon Ki Park (Republic of Korea)
- Mparany Mamy Richard Rajohnson (Madagascar).

The Security Council is expected to take action on the terms of office of the specified ICTR trial judges <u>during June 2012</u>.

### Protection of civilians in armed conflict

<u>S/PRST/2010/25 of 22 November 2010</u> Last para.: the Security Council requests the Secretary-General to submit his next report on the protection of civilians by May 2012.

The report of the Secretary-General dated 22 May 2012 (S/2012/376) if before the Security Council.

### S/PRST/2002/41 of 20 December 2002

Last para.: the Security Council recognizes the importance of a comprehensive, coherent and action-oriented approach to the protection of civilians in armed conflict. It encourages further cooperation between Member States, OCHA, DPA, DPKO, UNHCR, UNRWA, OHCHR, UNDP and other relevant United Nations agencies and offices, bearing also in mind the contents of resolutions 1325 on women, peace and security and 1379 on children in armed conflict; welcomes the regional workshops and encourages Member States to give them their operational and financial support. The Security Council requests the Secretary-General to submit by June 2004 his next report on the protection of civilians in armed conflict, including information on the implementation of Security Council resolutions previously adopted on this subject and any other matter he wishes to bring to the attention of the Council. It also welcomes the oral briefings to be given to the Council <u>every six months</u>, including progress made to further develop the road map concept, as set out in the most recent report by the Secretary-General (S/2002/1300)."

## United Nations peacekeeping operations

#### S/PRST/2009/24 of 5 August 2009

Encourages the Secretariat to deepen its efforts to review peacekeeping operations and to provide enhanced planning and support and in this regard, states the intention of the Security Council to give careful consideration to the support strategy provided in the Secretariat non-paper, *A New Partnership Agenda: Charting a New Horizon for UN Peacekeeping.* 

## S/PRST/2010/2 of 12 February 2010

Last para.: States that the Security Council remains committed to improving further the overall effectiveness of United Nations peacekeeping.

#### S/PRST/2011/17 of 26 August 2011

Last para: the Council commits to making progress on the issue of more meaningful engagement with Troop Contributing Countries and Police Contributing Countries and to reviewing progress in 2012.
