## AFRICA

#### Burundi – BNUB

Resolution 2137 (2014) of 13 February 2014

Para.1: Extends until <u>31 December 2014</u> the mandate of BNUB, requesting it, consistent with paragraphs 3 (a) to (d) of the resolution 1959 (2010) and 2 (a) and (b) of the resolution 2027 (2011), to focus on and support the Government of Burundi in the areas (a) to (e) of paragraph 1 of resolution 2090 (2013);

The mandate of BNUB will expire on <u>31 December 2014</u>.

## Central African Republic – MINUSCA

Resolution 2149 (2014) of 10 April 2014

Para.40: Decides that MINUSCA may, within the limits of its capacities and areas of deployment, at the formal request of the Transitional Authorities and in areas where national security forces are not present or operational, adopt urgent temporary measures on an exceptional basis and without creating a precedent and without prejudice to the agreed principles of peacekeeping operations, which are limited in scope, time bound and consistent with the objectives set forth in paragraphs 30 (a) and 30 (f) above, to maintain basic law and order and fight impunity and requests the Secretary-General to report to the Security Council any measures that may be adopted on this basis;

Para.50: Requests the Secretary-General to keep the Council regularly informed of the situation in the Central African Republic and the implementation of the mandate of MINUSCA, to report to the Council, on 1 August 2014, and then <u>every four months</u> from that date and to include in his reports to the Council updates on and recommendations related to the dynamic implementation MINUSCA's mandated tasks, including by providing appropriate financial information, information on the security situation, the priority political elements as defined above on political progress, progress on mechanisms and capacity to advance governance and fiscal management, relevant information on the progress, promotion and protection of human rights and international humanitarian law as well as a review of the troop and police levels, force and police generation and deployment of all MINUSCA's constituent elements;

The report of the Secretary-General is expected to be issued in December 2014.

# Central African Republic - French forces report on implementation of its mandate to support MINUSCA

## Resolution 2149 (2014) of 10 April 2014

Para.47: Authorizes French forces, within the limits of their capacities and areas of deployment, from the commencement of the activities of MINUSCA until the end of MINUSCA's mandate as authorized in this resolution, to use all necessary means to provide operational support to elements of MINUSCA from the date of adoption of this resolution, at the request of the Secretary-General and requests France to report to the Council on the implementation of this mandate as of 15 September 2014 and to coordinate its reporting with that of the Secretary-General referred to in paragraph 40 of this resolution;

#### Central African Republic – SG report on the findings of the commission of inquiry Resolution 2127 (2013) of 5 December 2013

Para.25: Further requests the Secretary-General to report to the Security Council on the findings of the commission of inquiry six months and <u>one year</u> after the adoption of this resolution;

The report of the Secretary-General is expected to be issued in December 2014.

## Central African Republic – Sanctions: Panel of Experts reports

Resolution 2127 (2013) of 5 December 2013

Para.59: Requests the Secretary-General to create for an initial period of thirteen months, in consultation with the Committee, and to make the necessary financial and security arrangements to support the work of the Panel, a group of up to five experts ("Panel of Experts"), under the direction of the Committee to carry out the following tasks:

(c) Provide to the Council, after discussion with the Committee, an update no later than 5 March 2014, an interim report by 5 July 2014 and a final report no later than <u>5 November 2014</u>;

The final report of the Panel of Experts dated 29 October 2014 (S/2014/762) is before the Security Council.

## Central African region – UNOCA and LRA

S/PRST/2014/8 of 12 May 2014

Last para: The Security Council requests that the Secretary-General keep it informed on the activities of UNOCA, progress made in conducting assessments of the LRA's evolving area of operations and logistical and support networks, and the efforts being undertaken respectively by missions in the region and other relevant United Nations agencies to implement the UN's Regional Strategy, including through a single report on UNOCA and the LRA to be submitted before <u>15</u> November 2014.

The report of the Secretary-General dated 13 November 2014 (S/2014/812) is before the Security Council.

## Côte d'Ivoire – UNOCI

Resolution 2162 (2014) of 25 June 2014

Para.38: Requests the Secretary-General to keep the Council regularly informed of the situation in Côte d'Ivoire and the implementation of the mandate of UNOCI and to provide to it a midterm report no later than <u>15 December 2014</u> and a final report no later than 15 May 2015 on the situation on the ground and the implementation of this resolution;

The midterm report of the Secretary-General is expected to be provided no later than <u>15 December</u> <u>2014</u>.

## Democratic Republic of the Congo – MONUSCO

Resolution 2147 (2014) of 28 March 2014

Para.39: Requests that the Secretary-General conduct a thorough Strategic Review of MONUSCO and the wider UN presence in DRC in order to provide recommendations on MONUSCO's future objectives, activities, exit strategy and effective deployment of resources, to the Security Council by

<u>30 December 2014</u>, bearing in mind the need to continue to increase the effectiveness of the mission;

The Strategic Review is expected to be provided by <u>30 December 2014</u>.

Para.40: Requests the Secretary-General to report to the Council <u>every three months</u> on: (i) the situation on the ground, including sexual violence and the impact of conflict on women and children;

(ii) progress made by the DRC in the implementation of its commitments under the PSC Framework, including through the establishment and implementation of a national security sector reform roadmap and the creation of a Congolese "Rapid Reaction Force", and on the implementation of the DDR and DDRRR plans;

(iii) the implementation by MONUSCO of its mandate, including the activities of the Intervention brigade, its reconfiguration to conduct the tasks set out above and the ongoing transfer of responsibilities to other actors;

(iv) the risks and their implications for the safety and the security for the UN personnel and facilities as a result of the possible military operations as well as measures taken to strengthen their security and mitigate risks;

The report of the Secretary-General is expected to be issued in December 2014.

## Liberia – UNMIL

Resolution 2176 (2014) of 15 September 2014 Para.1: Decides to extend the mandate of UNMIL until <u>31 December 2014;</u>

The mandate of UNMIL will expire on <u>31 December 2014</u>.

A meeting between the Security Council and the troop-contributing countries will take place before the expiry of the UNMIL mandate.

## Liberia – Sanctions: Mandate

Resolution 2128 (2013) of 10 December 2013

Para.2: Decides for a period of <u>12 months</u> from the date of adoption of this resolution:

(a) To renew the measures on travel imposed by paragraph 4 of resolution 1521 (2003);

(b) To renew the measures on arms, previously imposed by paragraph 2 of resolution 1521 (2003) and modified by paragraphs 1 and 2 of resolution 1683 (2006), by paragraph 1 (b) of resolution 1731 (2006), by paragraphs 3, 4, 5 and 6 of resolution 1903 (2009), and by paragraph 3 of resolution 1961 (2010), and to modify the associated notification requirements as follows:

The measures will expire on <u>10 December 2014</u>.

## Liberia – Sanctions: Panel of Experts mandate and final report

Resolution 2128 (2013) of 10 December 2013

Para.5: Decides to extend the mandate of the Panel of Experts appointed pursuant to paragraph 9 of resolution 1903 (2009) for a period of <u>12 months</u> from the date of adoption of this resolution to undertake the following tasks in close collaboration with the Government of Liberia and the Côte d'Ivoire Group of Experts:

The mandate of the Panel of Experts will expire on <u>10 December 2014</u>.

Para.5 (b): To provide to the Council, after discussion with the Committee, a midterm report no later than 1 June 2014 and a final report no later than <u>1 December 2014</u> on all the issues listed in this paragraph, and to provide informal updates to the Committee as appropriate before those dates;

The final report of the Panel of Experts dated 19 November 2014 (S/2014/831) is before the Security Council.

## Liberia – Sanctions: Assessment mission report

PSC letter of 16 July 2014 (S/2014/504)

Second para.: As an outcome of the review, the members of the Security Council request the Secretary-General to conduct an assessment mission and report to the Security Council, by <u>1</u> October 2014, on the progress that Liberia has made towards meeting the conditions set out in resolution 1521 (2003) for the termination of sanctions, and to provide recommendations on United Nations assistance and other technical assistance to the Government of Liberia in;

The report of the Secretary-General dated 29 September 2014 (S/2014/707) is before the Security Council.

## Libya – UNSMIL

Resolution 2144 (2014) of 14 March 2014

Para.18: Requests the Secretary-General to report to the Security Council on the implementation of this resolution, including all elements of UNSMIL's mandate, every 90 days;

The Secretary-General is expected to report to the Security Council in December 2014.

## Libya – Sanctions: Committee reports

Resolution 1970 (2011) of 26 February 2011

Para.24: Decides to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council (herein "the Committee"), to undertake to following tasks:

(e) To report within thirty days to the Security Council on its work for the first report and thereafter to report as deemed necessary by the Committee.

The Chair of the 1970 Committee is expected to report in December 2014.

## Mali – MINUSMA

#### Resolution 2164 (2014) of 25 June 2014

Para.33: Requests the Secretary-General to report to the Security Council within three months of the adoption of this resolution, focusing on the implementation of the Ouagadougou Preliminary Agreement, the expansion of the Force's presence in the North of Mali, and benchmarks to assess progress on the implementation of the priority tasks of MINUSMA's mandate, as defined by paragraph 13 above, and then, <u>every three months</u>, to report on the implementation of this resolution, in particular on the progress achieved on the benchmarks;

The report of the Secretary-General is expected to be issued in December 2014.

#### Mali – Report by France on implementation of mandate to support MINUSMA Resolution 2164 (2014) of 25 June 2014

Para.26: Authorizes French forces, within the limits of their capacities and areas of deployment, to use all necessary means until the end of MINUSMA's mandate as authorized in this resolution, to intervene in support of elements of MINUSMA when under imminent and serious threat upon request of the Secretary-General, requests France to report to the Council on the implementation of this mandate in Mali and to <u>coordinate its reporting with the reporting by the Secretary-General</u> referred to in paragraph 33 below;

## Peace & Security in Africa – UN Integrated Strategy for the Sahel

S/PRST/2014/17 of 27 August 2014

Last Para.: The Security Council requests the Secretary-General to inform it of the progress toward the implementation of the United Nations Integrated Strategy for the Sahel through an oral briefing by <u>15 December 2014</u>, and through a report and a briefing no later than 30 November 2015.

The oral briefing is expected to be held by <u>15 December 2014</u>.

## Somalia – AU reports on AMISOM

Resolution 2093 (2013) of 6 March 2013

Para.8: Requests the AU to keep the Security Council regularly informed on the implementation of AMISOM's mandate through the provision of written reports to the Secretary-General <u>every 90 days</u> after the adoption of this resolution.

## Sudan – UNAMID

## Resolution 2173 (2014) of 27 August 2014

Para.26: Requests the Secretary-General to report to the Council <u>every 90 days</u> following adoption of this resolution on UNAMID, including: information on the political, humanitarian and security situation in Darfur, including detailed reporting on incidents of violence and attacks against civilians, by whomsoever perpetrated;

information on violations of the Status of Forces Agreement, as well as violations of international humanitarian law perpetrated by any party to the conflict; developments and progress towards achievement of UNAMID's strategic priorities and benchmarks; developments and progress in addressing the challenges facing UNAMID as identified in the review of UNAMID; and on the implementation of this resolution;

The report of the Secretary-General dated 26 November 2014 (S/2014/852) is before the Security Council.

## Sudan – UNAMID

## Resolution 2173 (2014) of 27 August 2014

Para. 5: Welcomes the steps taken so far by UNAMID to implement the review of UNAMID conducted pursuant to resolution 2113 (2014); requests continued swift and full implementation of the review, including the streamlining of all UNAMID's components and aligning of activities to support achievement of its strategic priorities, and the discontinuing of all other tasks not aligned to the Mission's strategic priorities; stresses the importance of the appropriate distribution of tasks and coordination between UNAMID and the UNCT in order to implement the review of UNAMID; and requests a detailed update on the streamlining of the civilian component by <u>15 September 2014;</u>

The detailed update dated 16 September 2014 (S/2014/670) is before the Security Council.

## Sudan/South Sudan – UNISFA

#### Resolution 2179 (2014) of 14 October 2014

Para.25: Requests the Secretary-General to continue to inform the Council of progress in implementing UNISFA's mandate in two written reports, no later than <u>1 December 2014</u> and 2 February 2015 respectively, and continue to bring to the Council's immediate attention any serious violations of the above referenced agreements;

The report of the Secretary-General is expected to be provided no later than <u>1 December 2014</u>.

#### Sudan/South Sudan – SG to inform SC on status of compliance with resolution 2046 (2012) Resolution 2046 (2012) of 2 May 2012

Para.6: Requests the Secretary-General to consult with the African Union on the implementation of this resolution and the decisions of the AU PSC, to work closely with the AUHIP in support of its facilitation efforts, and to inform the Security Council within 15 days and in two week intervals thereafter on the status of compliance by Sudan, South Sudan, and the SPLM-N with the decisions set forth in this resolution, and expresses its intention, in the event that any or all of the parties have not complied with the decisions set forth in this resolution, to take appropriate additional measures under Article 41 of the Charter as necessary.

#### Note by the President of 11 November 2013 (S/2013/657)

Following consultations among the members of the Security Council, it has been agreed that issues pertaining to the Sudan and South Sudan, including the African Union/United Nations Hybrid Operation in Darfur (UNAMID), the United Nations Interim Security Force for Abyei (UNISFA), the United Nations Mission in South Sudan (UNMISS) and Council resolution 2046 (2012), will, as from 11 November 2013, be considered under the agenda item entitled "Reports of the Secretary-General on the Sudan and South Sudan". In addition, members of the Security Council agreed to amend the reporting period established in paragraph 6 of resolution 2046 (2012) to one-month intervals.

## Note by the President of 21 August 2014 (S/2014/613)

Following consultations among the members of the Security Council, it has been agreed to amend the reporting period established in paragraph 6 of resolution 2046 (2012) and subsequently amended in a note by the President of the Security Council (S/2013/657) to three-month intervals.

The Secretary-General is expected to report to the Security Council in December 2014.

## Sudan – ICC Prosecutor briefing

Resolution 1593 (2005) of 31 March 2005

Para.8: Invites the Prosecutor to address the Council within three months of the date of adoption of this resolution and <u>every six months</u> thereafter on actions taken pursuant to this resolution.

The ICC Prosecutor is expected to brief the Council in December 2014.

## UN Office for West Africa (UNOWA) – Reports

#### Letter from PSC of 23 December 2013 (S/2013/759)

The members of the Security Council concur with the recommendation contained in your twelfth report on UNOWA (S/2013/732) to extend its mandate for a further period of three years, from 1 January 2014 to 31 December 2016. The members of the Council request that you report to the Council <u>every six months</u> on the fulfilment by UNOWA of its mandate.

The report of the Secretary-General is expected to be issued in December 2014.

## ASIA/MIDDLE EAST

#### Afghanistan – UNAMA

Resolution 2145 (2014) of 17 March 2014

Para.44: ...and requests the Secretary-General to continue to include in his reports to the Security Council relevant information on the process of integration of women into the political, economic and social life of Afghanistan;

Para.48: Requests that the Secretary-General reports to the Council every three months on developments in Afghanistan, and to include in his reports an evaluation of progress made against the benchmarks for measuring and tracking progress in the implementation of UNAMA's mandate, including at the subnational level, and priorities as set out in this resolution;

The report of the Secretary-General is expected to be issued in December 2014.

## Afghanistan – ISAF mandate and final report

Resolution 2120 (2013) of 10 October 2013

Para.1: Decides to extend the authorization of the International Security Assistance Force (ISAF), as defined in resolution 1386 (2001) and 1510 (2003), for a period of twelve months until <u>31 December</u> <u>2014</u>;

The authorisation of ISAF will expire on <u>31 December 2014</u>.

## Resolution 2120 (2013) of 10 October 2013

Para.8: Requests the leadership of ISAF to keep the Security Council regularly informed, through the United Nations Secretary-General, on the implementation of its mandate, including through the timely provision of quarterly reports, and its final report in <u>December 2014</u> should be a comprehensive one;

The letter of the Secretary-General dated 28 November 2014 (S/2014/856) is before the Security Council.

## The situation in the Middle East, including the Palestinian question

<u>Resolution 1322 (2000) of 7 October 2000</u> Para.7: Invites the Secretary-General to continue to follow the situation and to keep the Council informed.

# Middle East (Syria) – OPCW report to SC (through SG) on implementation of resolution 2118 (2013)

## Resolution 2118 (2013) of 27 September 2013

Para.12: Decides to review on a regular basis the implementation in the Syrian Arab Republic of the decision of the OPCW Executive Council of 27 September 2013 and this resolution, and requests the Director-General of the OPCW to report to the Security Council, through the Secretary-General, who shall include relevant information on United Nations activities related to the implementation of this resolution, within 30 days and <u>every month</u> thereafter, and requests further the Director-General of the OPCW and the Secretary-General to report in a coordinated manner, as needed, to the Security Council, non-compliance with this resolution or the OPCW Executive Council decision of 27 September 2013.

# Middle East (Syria) – SG report to SC on implementation of resolutions 2139 (2014) and 2165 (2014)

## Resolution 2139 (2014) of 22 February 2014

Para.17: Requests the Secretary-General to report to the Council on the implementation of this resolution by all parties in Syria, in particular paragraphs 2 through 12, in 30 days of its adoption and <u>every 30 days</u> thereafter, and upon receipt of the Secretary-General's report, expresses its intent to take further steps in the case of non-compliance with this resolution;

#### Resolution 2165 (2014) of 14 July 2014

Para. 10: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance with it by all Syrian parties to the conflict, within the framework of its reporting on resolution 2139 (2014);

The Secretary-General is expected to report to the Security Council in December 2014.

## Middle East (UNDOF) – Mandate and report

#### Resolution 2163 (2014) of 25 June 2014

Para.6: Decides to renew the mandate of the United Nations Disengagement Observer Force for a period of six months, that is, until <u>31 December 2014</u>, and requests the Secretary-General to ensure that UNDOF has the required capacity and resources to fulfil the mandate in a safe and secure way;

The mandate of UNDOF will expire on <u>31 December 2014</u>.

A meeting between the Security Council and the troop-contributing countries will take place before the expiry of the UNDOF mandate.

Para.7: Requests the Secretary-General to report <u>every 90 days</u> on developments in the situation and the measures taken to implement resolution 338 (1973).

The report of the Secretary-General is expected to be issued in December 2014.

## Middle East (Yemen) – SG to report on developments in Yemen

Resolution 2140 (2014) of 26 February 2014

Para.33: requests the Secretary-General to continue to report on developments in Yemen, including on the implementation of the outcome of the comprehensive National Dialogue Conference every <u>60</u> days;

The Secretary-General is expected to report to the Security Council in <u>December 2014</u>. **Middle East (Yemen) – Sanctions committee report to SC** Resolution 2140 (2014) of 26 February 2014

Para.19: (e) To report within 60 days to the Security Council on its work and thereafter to report as deemed necessary by the Committee;

The Chair of the 2140 Committee is expected to report to the Security Council in December 2014.

## EUROPE

#### Resolutions 1160 (1998), 1199 (1998), 1203 (1998), 1239 (1999) and 1244 (1999) – UNMIK Resolution 1244 (1999) of 10 June 1999

Para.20: Requests the Secretary-General to report to the Council at regular intervals on the implementation of this resolution, including reports from the leaderships of the international civil and security presences, the first reports to be submitted within 30 days of the adoption of this resolution.

The report of the Secretary-General dated 31 October 2014 (S/2014/773) is before the Security Council.

## OTHER

## Non-proliferation (Iran) – Sanctions: Committee reports

Resolution 1737 (2006) of 27 December 2006

Para.18: Decides to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council, to undertake the following tasks:

(h) to report at least <u>every 90 days</u> to the Security Council on its work and on the implementation of this resolution, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraphs 3, 4, 5, 6, 7, 8, 10 and 12 above.

The Chair of the 1737 Committee is expected to report to the Security Council in December 2014.

## Non-proliferation (Iran) – Sanctions: Panel of Experts reports

Resolution 2159 (2014) of 9 June 2014

Requests the Panel of Experts to provide to the Committee no later than 9 November 2014 a midterm report on its work, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its midterm report by <u>9 December 2014</u>, and requests also a final report to the Committee by 9 May 2015 with its findings and recommendations, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its findings and recommendations, and further requests that, after a discussion with the Committee, the Panel of Experts submit to the Council its final report by 9 June 2015;

The midterm report of the Panel of Experts is expected to be submitted by <u>9 December 2014</u>.

## Briefing by outgoing Chairs of Security Council subsidiary bodies

The outgoing Chairs of Security Council sanctions committees and working groups are expected to brief the Security Council in <u>December 2014</u>.

SG report of 3 May 1993 (S/25704)

## E. Annual report

Para.37: The International Tribunal should submit an annual report on its activities to the Security Council and the General Assembly.

Para.138: The corresponding article of the statute would read:

#### Article 34

Annual Report

The President of the International Tribunal shall submit an annual report of the International Tribunal to the Security Council and to the General Assembly.

## Resolution 827 (1993) of 25 May 1993

Para.2: Decides hereby to establish an international tribunal for the sole purpose of prosecuting persons responsible for serious violations of international humanitarian law committed in the territory of the former Yugoslavia between 1 January 1991 and a date to be determined by the Security Council upon the restoration of peace and to this end to adopt the Statute of the International Tribunal annexed to the above-mentioned report;

The annual report of the ICTY dated 1 August 2014 (S/2014/556) is before the Security Council.

## ICTR – Annual report

## Resolution 955 (1994) of 8 November 1994

Para.2: Decides hereby, having received the request of the Government of Rwanda (S/1994/1115), to establish an international tribunal for the sole purpose of prosecuting persons responsible for genocide and other serious violations of international humanitarian law committed in the territory of Rwanda and Rwandan citizens responsible for genocide and other such violations committed in the territory of neighbouring States, between 1 January 1994 and 31 December 1994 and to this end to adopt the Statute of the International Criminal Tribunal for Rwanda annexed hereto;

Annex <u>Article 32</u> <u>Annual report</u> The President of the International Tribunal for Rwanda shall submit an annual report of the International Tribunal for Rwanda to the Security Council and to the General Assembly.

## ICTR – Term of office of permanent judges

## Resolution 2080 (2012) of 12 December 2012

Para.1: Decides to extend the term of office of the following permanent judges at the International Tribunal, who are members of the Appeals Chamber, until <u>31 December 2014</u> or until the completion of the cases to which they are assigned, if sooner:

- Mehmet Güney (Turkey)
- Khalida Rachid Khan (Pakistan)
- Arlette Ramaroson (Madagascar)
- Bakhtiyar Tuzmukhamedov (Russian Federation)
- Andrésia Vaz (Senegal)

The term of office of the judges will expire on <u>31 December 2014</u>.

## ICTR – Term of office of ICTR President

## Resolution 2054 (2012) of 29 June 2012

Para.2: Takes note of the intention of the International Tribunal to complete all remaining judicial work by 31 December 2014 and decides, bearing in mind the expiry of his term of office on 30 June 2012, to extend the term of office of Judge Vagn Joensen (Denmark), on an exceptional basis, until <u>31 December 2014</u> so that he may continue to perform the functions required of him as trial judge and President of the International Tribunal, to complete the work of the Tribunal and expresses its intention to review this decision in June 2013.

The term of office of Judge Vagn Joensen (Denmark) will expire on 31 December 2014.

## ICTY – Term of office of permanent and ad litem judges

## Resolution 2130 (2013) of 18 December 2013

Para.6: Requests each Tribunal to provide to the Council, by 31 May 2004 and <u>every six months</u> thereafter, assessments by its President and Prosecutor, setting out in detail the progress made towards implementation of the Completion Strategy of the Tribunal, explaining what measures have

been taken to implement the Completion Strategy and what measures remain to be taken, including the transfer of cases involving intermediate and lower rank accused to competent national jurisdictions; and expresses the intention of the Council to meet with the President and Prosecutor of each Tribunal to discuss these assessments.

The assessments of the ICTY (S/2014/827) and the ICTR (S/2014/829) dated 19 November 2015 are before the Security Council.

## ICTY / ICTR – completion of all remaining work

## Resolution 1966 (2010) of 22 December 2010

Para.3: Requests the ICTY and the ICTR to take all possible measures to expeditiously complete all their remaining work as provided by this resolution no later <u>than 31 December 2014</u>, to prepare their closure and to ensure a smooth transition to the Mechanism, including through advance teams in each of the Tribunals.

## Residual Mechanism – Annual report and progress reports

Resolution 1966 (2010) of 22 December 2010

Para.16: Requests the President of the Mechanism to submit an <u>annual report</u> to the Security Council and to the General Assembly, and the President and the Prosecutor of the Mechanism to submit <u>six-monthly</u> reports to the Security Council on the progress of the work of the Mechanism;

The annual report of the President of the Mechanism dated 1 August 2014 (S/2014/555) and the progress reports dated 19 November 2015 (S/2014/826) are before the Security Council.

#### Peacebuilding Commission – Organizational Committee: election of two E-10 members Resolution 1645 (2005) of 20 December 2005

Para.6: Decides that members of the Organizational Committee shall serve for renewable terms of two years, as applicable.

## Resolution 1646 (2005) of 20 December 2005

Para.1: Decides pursuant to paragraph 4 (a) of resolution 1645 (2005) that the permanent members listed in article 23 (1) of the Charter shall be members of the Organizational Committee of the Peacebuilding Commission and that, in addition, the Council shall select annually two of its elected members to participate in the Organizational Committee.

The Security Council is expected to announce by <u>January 2015</u> the two members elected to serve one-year terms on the PBC Organizational Committee for the year 2015.

## Peacebuilding – SG report

## S/PRST/2012/29 of 20 December 2012

Last para.: "The Security Council requests the Secretary-General to brief the Council and the General Assembly by December 2013 and submit a report no later than <u>December 2014</u> on further progress in the United Nations peacebuilding efforts in the aftermath of conflict, including the issue of women's participation in peacebuilding, and placing particular emphasis on the impact on the ground, including lessons learned from United Nations peacebuilding activities in country specific context, and on progress in taking forward the elements included in this statement, taking into consideration the views of the Peacebuilding Commission."

The report of the Secretary-General dated 23 September 2014 (S/2014/694) is before the Security Council.

# Peacekeeping operations – lessons learned exercise on transitions and specific recommendations

## Resolution 2167 (2014) of 28 July 2014

Para.13: Requests in that context the Secretary-General to initiate in full and close cooperation with the African Union a lessons learned exercise on the transitions from the African Union peace operations to United Nations peacekeeping operations in Mali and the Central African Republic and to produce specific recommendations that could be used for possible future transitional arrangements not later than <u>31 December 2014</u>;

## Protection of civilians in armed conflict - Oral briefing

## S/PRST/2002/41 of 20 December 2002

Last para.: "The Security Council recognizes the importance of a comprehensive, coherent and action-oriented approach to the protection of civilians in armed conflict. It encourages further cooperation between Member States, OCHA, DPA, DPKO, UNHCR, UNRWA, OHCHR, UNDP and other relevant United Nations agencies and offices, bearing also in mind the contents of resolutions 1325 on women, peace and security and 1379 on children in armed conflict; welcomes the regional workshops and encourages Member States to give them their operational and financial support. The Security Council requests the Secretary-General to submit by June 2004 his next report on the protection of civilians in armed conflict, including information on the implementation of Security Council resolutions previously adopted on this subject and any other matter he wishes to bring to the attention of the Council. It also welcomes the oral briefings to be given to the Council <u>every six</u> <u>months</u>, including progress made to further develop the road map concept, as set out in the most recent report by the Secretary-General (S/2002/1300)."

# Cooperation between UN and regional/subregional organizations – Recommendations on enhancing cooperation between the UN and OIC

## Resolution 1809 (2008) of 16 April 2008

Para.17: Requests the Secretary-General to include in his regular reporting to the Security Council, assessments of progress on the cooperation between the United Nations and relevant regional organizations;

## S/PRST/2013/12 of 6 August 2013

Last para.: The Council further requests that the Secretary-General includes in his next biannual report to the Security Council and the General Assembly on Cooperation between the United Nations and regional and other organizations, recommendations on ways to enhance cooperation between the United Nations and relevant regional and subregional organizations and arrangements.

## S/PRST/2013/16 of 28 October 2013

Last para: "The Security Council requests the Secretary-General to include in his <u>next biannual</u> <u>report</u> to the Security Council and the General Assembly on Cooperation between the United Nations and regional and other organizations, recommendations on ways to enhance cooperation between the United Nations and the Organization of Islamic Cooperation."

The report of the Secretary-General dated 4 August 2014 (S/2014/560) is before the Security Council.

# Work of the UN to help states, sub-regional and regional entities in Africa in fighting terrorism – SG report

## S/PRST/2013/5 of 13 May 2013

Last para: invites the Secretary-General to submit, within 6 months, a concise report providing a comprehensive survey and assessment of the UN's relevant work to help States, sub-regional and regional entities in Africa in fighting terrorism, with the view to continue consideration of possible steps in this regard.
