# AFRICA

#### Burundi: SG reports on the situation in Burundi

Resolution 2303 (2016) of 29 July 2016

Para.19: Requests the Secretary-General to report to the Security Council on the situation in Burundi <u>every three months</u> after the adoption of this resolution, including on any public incidents of incitements to hatred and violence, as well as on steps to ensure the deployment of the United Nations police component and on possible adaptations of the United Nations police component as referred to in paragraphs 13 and 14 of this resolution, and further requests the Secretary-General to provide written reports immediately to the Security Council, as necessary, on grave security incidents, violations of international humanitarian law and violations or abuses of human rights, as applicable, of which the United Nations police component in Burundi, together with OHCHR, has knowledge, whoever perpetrates them;

The report of the Secretary-General is expected to be issued in January 2017.

#### CAR: Sanctions: Arms embargo, travel ban and assets freeze

#### Resolution 2262 (2016) of 27 January 2016

Para. 1: Decides that, until <u>31 January 2017</u>, all Member States shall continue to take the necessary measures to prevent the direct or indirect supply, sale or transfer to the CAR, from or through their territories or by their nationals, or using their flag vessels or aircraft, of arms and related materiel of all types, including weapons and ammunition, military vehicles and equipment, paramilitary equipment, and spare parts for the aforementioned, and technical assistance, training, financial or other assistance, related to military activities or the provision, maintenance or use of any arms and related materiel, including the provision of armed mercenary personnel whether or not originating in their territories, and decides further that this measure shall not apply to:

Para.5: Decides that, until <u>31 January 2017</u>, all Member States shall continue to take the necessary measures to prevent the entry into or transit through their territories of individuals designated by the Committee, provided that nothing in this paragraph shall oblige a State to refuse its own nationals entry into its territory;

Para.8: Decides that all Member States shall, until <u>31 January 2017</u>, continue to freeze without delay all funds, other financial assets and economic resources which are on their territories, which are owned or controlled, directly or indirectly, by the individuals or entities designated by the Committee, or by individuals or entities acting on their behalf or at their direction, or by entities owned or controlled by them, and decides further that all Member States shall continue to ensure that any funds, financial assets or economic resources are prevented from being made available by their nationals or by any individuals or entities within their territories, to or for the benefit of the individuals or entities designated by the Committee;

The measures on arms embargo, travel ban and assets freeze will expire on 31 January 2017.

# CAR: Sanctions: SC review of Panel of Experts mandate

Resolution 2262 (2016) of 27 January 2016

Para.22: Decides to extend the mandate of the Panel of Experts until 28 February 2017 and, expresses its intent to review the mandate and take appropriate action regarding further extension no later than <u>31 January 2017</u> and requests the Secretary-General to take the necessary administrative measures as expeditiously as possible to support its action;

The PoE mandate is expected to be reviewed no later than <u>31 January 2017</u>.

# CAR: Sanctions: Panel of Experts final report

Resolution 2262 (2016) of 27 January 2016

Para.23 (c): Provide to the Committee a midterm report no later than 30 July 2016 and a final report to the Security Council, after discussion with the Committee, by <u>31 December 2016</u> on the implementation of the measures imposed by paragraphs 54 and 55 of resolution 2127 (2013) and paragraphs 30 and 32 of resolution 2134 (2014) renewed by paragraphs 1, 2, 5 and 8 of this resolution

# Côte d'Ivoire: SG report on the implementation of the mandate of UNOCI and its phased drawdown

# Resolution 2284 (2016) of 28 April 2016

Para.36: Requests the Secretary-General to keep the Council regularly informed of the situation in Côte d'Ivoire, and to provide to it a report by <u>31 January 2017</u> on the implementation of the mandate of UNOCI and its phased drawdown, including an update on the continued transition of the security responsibilities to the Government of Côte d'Ivoire, and an oral briefing by 30 June 2017 on the completion of UNOCI's mandate and its closure;

The report of the Secretary-General is expected to be issued by <u>31 January 2017</u>.

# DRC: SG reports on MONUSCO

# Resolution 2277 (2016) of 30 March 2016

Para.50: Requests the Secretary-General to report to the Council <u>every three months</u> on the implementation of MONUSCO's mandate, including its Intervention Brigade, as set out in this resolution, including on:

(i) the situation on the ground, including updates on operations to neutralize armed groups and any instances where the Mission's protection of civilians obligations are not fully met, as well as sexual violence and the impact of conflict on women and children;

(ii) progress made by the DRC on protecting human rights, on the electoral process, including on the provisions of paragraphs 7, 8 and 9 above, and in the implementation of its commitments under the PSC Framework, including through the establishment and implementation of a national SSR

roadmap, its provincial stabilisation plan supported by the ISSSS and on the implementation of the DDR and DDRRR plans;

(iii) progress in the implementation of the recommendations of the strategic review, notably the measures taken to transform MONUSCO's Force, including the deployment of rapidly deployable battalions, to become more efficient and effective in implementing its mandate;

Para.48: Reiterates the need for a clear exit strategy of the Intervention Brigade, including through sustainable progress in ending the threat of armed groups and the implementation of sustainable SSR which may include the development of a Congolese rapid reaction force, requests the Secretary-General to report <u>by December 2016</u> on the implementation of the tasks of the Intervention Brigade on the basis of the evolution of the situation on the ground, its integration within MONUSCO and its effectiveness, as well as on the progress of the transformation of the Force;

The report of the Secretary-General is expected to be issued in January 2017.

Para.9: Requests the Group of Experts to fulfil its mandate as consolidated below, and to provide to the Council, after discussion with the Committee, a mid-term report no later than <u>30 December</u> <u>2016</u>, and a final report no later than 15 June 2017, as well as submit monthly updates to the Committee, except in the months where the mid-term and final reports are due:

# Mali: SG reports on MINUSMA, focusing on progress in the implementation of the Agreement on Peace and Reconciliation and MINUSMA's efforts to support it

Resolution 2295 (2016) of 29 June 2016

Para.46: Requests the Secretary-General to report to the Security Council <u>every three months</u> after the adoption of this resolution on the implementation of this resolution, focusing on the progress in the implementation of the Agreement on Peace and Reconciliation in Mali and on MINUSMA's efforts to support it, and, in this regard, requests the Secretary-General to include in his December report benchmarks and timelines as referred to in paragraph 12, and, then, to report on these benchmarks in his regular reports;

The report of the Secretary-General is expected to be issued in January 2017.

# South Sudan: SG to provide detailed information on UNMISS force, impediments and obstructions

# Resolution 2304 (2016) of 12 August 2016

Para.16: Requests that the Secretary-General provide detailed information within 30 days on force generation, restructuring of the UNMISS force, logistical support and enablers, and civilian personnel to implement the mandate, as well as whether the Transitional Government of National Unity has maintained its consent in principle to deployment of the Regional Protection Force and not imposed any political or operational impediments to operationalizing the Regional Protection Force or obstructed UNMISS in the performance of its mandate, and requests the Secretary-General to review needs on the ground, and provide an updated assessment of the Regional Protection Force's operations,

deployment, and future requirements, as well as any political or operational impediments to operationalizing the Regional Protection Force and obstructions to UNMISS in performance of its mandate, within 30 days after the adoption of this resolution, and <u>every 30 days</u> thereafter;

The report of the Secretary-General is expected to be issued in January 2017.

# South Sudan: Sanctions: Panel of Experts updates

Resolution 2290 (2016) of 31 May 2016

Para.12: (d) Provide to the Council, after discussion with the Committee, an interim report by 1 December 2016, a final report by 1 May 2017, and except in the months when these reports are due, updates each month;

The update from the PoE is expected in January 2017.

# Somalia: SG to review UN presence and present options and recommendations to SC Resolution 2275 (2016) of 24 March 2016

Para. 6: Requests the Secretary-General to conduct a review of the United Nations presence in Somalia after the 2016 electoral process, to ensure that the United Nations is properly configured to support the next phase of state-building in Somalia, and to present options and recommendations to the Security Council by <u>30 January 2017</u>;

The Secretary-General is expected to provide an assessment in January 2017.

# Sudan: SG recommendations on what practical steps need to be taken by Sudanese parties with support of UNAMID to make tangible progress towards achieving benchmarks <u>Resolution 2296 (2016) of 29 June 2016</u>

Para.33: Takes note of ongoing consultations between the United Nations, the African Union and the Government of Sudan, notably in the frameworks of the Tripartite mechanism and the Joint Working Group, including discussion of operational and logistical issues pertaining to the mission's operation as well as the development of an exit strategy in accordance with the mission's benchmarks; requests the Secretary-General to make recommendations, within 120 days of the adoption of this resolution, including by building on any agreed recommendations of the Joint Working Group and undertakes to consider the Secretary-General's recommendations in due course, on what practical steps need to be taken by all Sudanese parties with the support of UNAMID in order to make tangible progress towards achieving the benchmarks;

(iii) developments and progress towards achievement of UNAMID's strategic priorities and benchmarks, including progress in response to the Secretary General's recommendations on practical steps requested in paragraph 33 of this resolution;

(iv) developments and progress in addressing the challenges facing UNAMID as identified in the review of UNAMID; and

(v) on the implementation of this resolution;

#### ISIL (Da'esh) and Al-Qaeda Sanctions: Office of Ombudsperson reports

<u>Resolution 2253 (2015) of 17 December 2015</u> Annex II, para.20: (c) Submit <u>biannual reports</u> summarizing the activities of the Ombudsperson to the Security Council.

The report of the Ombudsperson is expected to be issued in January 2017.

#### Non-proliferation (Iran): Joint Commission reports

Resolution 2231 (2015) of 20 July 2015

JCPOA Annex IV – Joint Commission para. 6.10.: The Joint Commission will report to the United Nations Security Council at least every 6 months on the status of the Procurement Working Group's decisions and on any implementation issues.

Note by PSC of 16 January 2016

Para.3: To facilitate its work under resolution 2231 (2015), the Security Council shall select on an annual basis one member to serve as its facilitator for the functions specified in the present note. The facilitator shall brief the other members of the Council on its work and the implementation of the resolution every six months, in parallel with the report submitted by the Secretary-General in accordance with paragraph 7 below.

The facilitator is expected to brief the Security Council in January 2017.

Para.1: Decides pursuant to paragraph 4 (a) of resolution 1645 (2005) that the permanent members listed in article 23 (1) of the Charter shall be members of the Organizational Committee of the Peacebuilding Commission and that, in addition, the Council shall select annually two of its elected members to participate in the Organizational Committee.

The Security Council is expected to announce by January 2017 the two members elected to serve on the PBC Organizational Committee.

# Security Council annual report: SC to complete introduction

Note by PSC of 10 December 2015 (S/2015/944)

Fourth para.: The report shall consist of an introduction, containing an agreed concise summary prepared on behalf of the Council under the coordination of the President of the Council for the month of July. In the case of the presidency for the month of July ending its tenure on the Council that year, the task of coordinating the introduction of the report shall then devolve on the member of the Council

next in English alphabetical order and who will not be leaving the Security Council that calendar year. The introduction to the report should continue to be approved by all members of the Council who served on the Council during the reporting period. The introduction, which should not exceed 10,000 words, may contain, inter alia, a brief description of the key activities and trends, and the nature of decisions taken by the Security Council during the period covered by the report. The introduction shall be completed <u>no later than 31 January</u> so as to allow the Secretariat enough time for translation.

The introduction to the annual report is expected to be completed no later than 31 January 2017.

# Terrorism/Cross-border crime: SG report on UN efforts to address the threat of terrorists benefitting from transnational organized crime in affected regions

# Resolution 2195 (2014) of 19 December 2014

Para.20: Requests the Secretary-General to submit to the Council a report on the efforts of the United Nations entities to address the threat of terrorists benefiting from transnational organized crime in affected regions, including Africa, with respect to matters with which the Council is seized, with input from the relevant entities of the United Nations system including the UNODC, CTED, the Analytical Support and Sanctions Monitoring Team, and other relevant CTITF entities;

Para.21: Further requests that the report include recommendations of concrete options for strengthening Member States' capabilities, including financing such proposed UN projects and activities to build capacity with existing resources and contributions in the UN system, as well as UN activities to reduce the negative impacts of terrorists benefiting from transnational organized crime including those relevant to its conflict resolution efforts with a focus on border security, counter-terrorist financing, and anti-money-laundering, and that the report be submitted to the Council no later than <u>six months</u> from the adoption of this resolution;

The report of the Secretary-General dated 21 May 2015 (S/2015/366) is before the Security Council.

# WMD: 1540 Committee report: review implementation

#### Resolution 1977 (2011) of 20 April 2011

Para.3: Decides that the 1540 Committee will conduct a comprehensive review on the status of implementation of resolution 1540 (2004), both after five years and prior to the renewal of its mandate, including, if necessary, recommendations on adjustments to the mandate, and will submit to the Security Council a report on the conclusions of those reviews, and decides that, accordingly, the first review should be held before December 2016;

#### Resolution 2325 (2016) of 15 December 2016
