#### AFRICA

#### Burundi: SG reports on the situation in Burundi

S/PRST/2017/13 of 2 August 2017

Antepenultimate para: The Security Council recalls its request [in para.19 of resolution 2303 (2016) of 29 July 2016] to the Secretary-General to report to the Security Council on the situation in Burundi every three months, to be reviewed after one year, including on any public incidents of incitements to hatred and violence, and changes to the situation on the ground, and *further requests* the Secretary-General to provide written reports immediately to the Security Council, as necessary, on grave security incidents, violations of international humanitarian law and violations or abuses of human rights, as applicable, of which the United Nations in Burundi has knowledge, whoever perpetrates them.

The report of the Secretary General is expected to be issued in January 2018.

#### CAR: Sanctions: Panel of experts final report

Resolution 2339 (2017) of 27 January 2017

Para. 28: (c) Provide to the Security Council, after discussion with the Committee, a midterm report no later than 30 July 2017, and a final report by 31 December 2017, on the implementation of the measures imposed by paragraphs 54 and 55 of resolution 2127 (2013) and paragraphs 30 and 32 of resolution 2134 (2014) renewed by paragraphs 1, 2, 5 and 12 of this resolution;

The final report of the PoE dated 6 December 2017 (S/2017/1023) is before the Security Council.

# CAR: Sanctions: Secretariat to provide options for elaboration of benchmarks to assess arms embargo and information on recommended working group

Resolution 2339 (2017) of 27 January 2017

Para. 29: Requests the Secretariat to provide to the Security Council, <u>by 30 May 2017</u>, options for the elaboration of benchmarks, in coordination with EUTM and other active partners in the field of SSR and in consultation with the CAR Authorities, to assess the arms embargo measures according to the progress of the SSR, including FACA and Internal Security Forces and their needs, as well as additional information on the Panel of Experts' recommended arms embargo working group to be potentially established within MINUSCA by the Security Council, including on the composition, tasks, functioning, resource requirements and implication with regards the implementation of MINUSCA's mandate, of such a working group, with reference to previous similar experiences in other UN Peacekeeping Missions;

The report of the Secretary-General dated 10 July (S/2017/597) is before the Security Council.

#### CAR: Sanctions: Arms embargo, travel ban and assets freeze

Resolution 2339 (2017) of 27 January 2017

Para. 1: Decides that, until 31 January 2018, all Member States shall continue to take the necessary measures to prevent the direct or indirect supply, sale or transfer to the CAR, from or through their territories or by their nationals, or using their flag vessels or aircraft, of arms and related materiel of all types, including weapons and ammunition, military vehicles and equipment, paramilitary equipment, and spare parts for the aforementioned, and technical assistance, training, financial or other assistance, related to military activities or the provision, maintenance or use of any arms and related materiel, including the provision of armed mercenary personnel whether or not originating in their territories, and decides further that this measure shall not apply to:

Para.5: Decides that, until 31 January 2018, all Member States shall continue to take the necessary measures to prevent the entry into or transit through their territories of individuals designated by the Committee, provided that nothing in this paragraph shall oblige a State to refuse its own nationals entry into its territory, and calls upon the CAR Government to enhance cooperation and information sharing with other States in this regard;

Para.12: Decides that all Member States shall, until 31 January 2018, continue to freeze without delay all funds, other financial assets and economic resources within their territories, which are owned or controlled, directly or indirectly, by the individuals or entities designated by the Committee, or by individuals or entities acting on their behalf or at their direction, or by entities owned or controlled by them, and decides further that all Member States shall continue to ensure that any funds, financial assets or economic resources are prevented from being made available by their nationals or by any individuals or entities within their territories, to or for the benefit of the individuals or entities designated by the Committee;

The measures on arms embargo, travel ban and assets freeze will expire on 31 January 2018.

#### CAR: Sanctions: SC review of Panel of Experts mandate

Resolution 2339 (2017) of 27 January 2017

Para. 27: Decides to extend the mandate of the Panel of Experts until 28 February 2018, expresses its intent to review the mandate and take appropriate action regarding further extension no later than 31 January 2018 and requests the Secretary-General to take the necessary administrative measures as expeditiously as possible to support its action;

The Security Council will review the mandate and take appropriate action no later than <u>31 January</u> <u>2018.</u>

#### DRC: SG reports on MONUSCO

Resolution 2348 (2017) of 31 March 2017

Para. 52: Requests the Secretary-General to report to the Council every three months on the implementation of MONUSCO's mandate, including its Intervention Brigade, as set out in this resolution, including on:

(i) progress made by the DRC on the implementation of the 31 December 2016 agreement and the electoral process, including on the provisions of paragraphs 1 to 6 above, as well as on the ways in which MONUSCO will be best prepared to address security risks and to monitor and report on human rights violations and abuses in the context of the elections, including in terms of deployment of the Force in areas identified as potential zones of instability and configuration of civilian and police

component of MONUSCO, sexual violence and the impact of conflict on women and children, and any gender considerations made;

(ii) the situation on the ground, including updates on operations to neutralize armed groups, in accordance with paragraph 34.i.d, and any instances where the Mission is not effectively fulfilling its protection of civilians mandate, and the circumstances surrounding these instances; (iii) progress made by the DRC on protecting human rights and in the implementation of its commitments under the PSC Framework, including through the establishment and implementation of a national SSR roadmap, its provincial stabilization plan supported by the ISSSS and on the implementation of the DDR and DDRRR plans;

(iv) progress in the implementation of the measures taken to transform MONUSCO's Force and improve its performance, including measures to ensure Force effectiveness as outlined in paragraphs 44 to 47, the deployment of rapidly deployable battalions and employment of the Intervention Brigade's capabilities, to become more mobile, efficient and effective in implementing its mandate, and on the definition of an exit strategy for MONUSCO, including the Intervention Brigade;

(v) the risks and their implications for the safety and the security for the United Nations personnel and facilities as a result of the possible military operations as well as measures taken to strengthen their security and mitigate risks;

The report of the Secretary-General is expected to be issued in January 2018.

#### DRC: SG to update SC in writing on implementation of the 31 December 2016 agreement Resolution 2348 (2017) of 31 March 2017

Para. 53: Requests the Secretary-General to update the Security Council in writing <u>every 45 days</u> on political and technical progress and obstacles to the implementation of the 31 December 2016 agreement, when no regular reports are due;

#### DRC: Sanctions: Group of Experts midterm report

Resolution 2360 (2017) of 21 June 2017

Para.6: Requests the Group of Experts to fulfil its mandate as consolidated below, and to provide to the Council, after discussion with the Committee, a mid-term report no later than 30 December 2017, and a final report no later than 15 June 2018, as well as submit monthly updates to the Committee, except in the months where the mid-term and final reports are due;

The GoE midterm report dated 21 December 2017 (S/2017/1091) is before the Security Council.

#### Libya: UNSMIL: SG to report to SC on the implementation of resolution 2376 (2017) Resolution 2376 (2017) of 14 September 2017

Para.7: Requests the Secretary-General to continue to report to the Security Council on the implementation of this resolution at least every 60 days;

The Secretary-General is expected to report in January 2018.

#### Mali: SG reports on MINUSMA on the implementation of resolution 2364 (2017)

Resolution 2364 (2017) of 29 June 2017

Para.47: Resolution 2358 (2017) of 14 June 2017

Requests the Secretary-General to report to the Security Council every three months after the adoption of this resolution on the implementation of this resolution, focusing:

(i) on the progress in the implementation of the Agreement on Peace and Reconciliation in Mali and on MINUSMA's efforts to support it, including through the benchmarks and timelines agreed between the Government of Mali and MINUSMA in December 2016, pursuant to resolution 2295 (2016);

(ii) on progress in the implementation of the measures taken to improve MINUSMA's effectiveness to implement its mandate, as outlined in paragraphs 31 to 36 above, including measures to enhance the safety and security of MINUSMA's personnel;

(iii) on coordination and exchange of information between MINUSMA, French forces and the FC-G5S as outlined in paragraph 42 above;

# Mali: SG to develop a mission-wide strategic plan on phased approach to implementation of MINUSMA's mandate and transition plan

Para.48: Further requests the Secretary-General, seeking perspectives from all relevant parties, to develop within 180 days after the adoption of this resolution a mission-wide strategic plan that: (i) articulates a concrete phased approach to implementation of MINUSMA's mandate;

(ii) presents a transition plan with a view to handing over relevant tasks to the UNCT based on their mandates and comparative advantages as well as a mapping of capabilities, and also with a view to a possible long-term exit strategy of the Mission on the basis of improved security and political conditions as well as the progress in the implementation of the Agreement;

### South Sudan: SG to provide detailed information on UNMISS force, impediments and obstructions

#### Resolution 2327 (2016) of 16 December 2016

Para. 31: Requests that the Secretary-General provide detailed information within 30 days on force generation, restructuring of the UNMISS force, logistical support and enablers, and civilian personnel to implement the mandate, as well as whether the TGNU has maintained its consent in principle to deployment of the RPF and not imposed any political or operational impediments to operationalizing the RPF or obstructed UNMISS in the performance of its mandate, and requests the Secretary-General to review needs on the ground, and provide an updated assessment of the RPF's operations, deployment, and future requirements, as well as any political or operational impediments to operationalizing the RPF and obstructions to UNMISS in performance of its mandate, within 30 days after the adoption of this resolution, and every 30 days thereafter;

The report of the Secretary-General is expected to be issued in January 2018.

#### Sudan: SG reports on UNAMID

Resolution 2363 (2017) of 29 June 2017

Para.41: Requests the Secretary-General to report to the Council every 60 days following adoption of this resolution on UNAMID, including:

(i) information on the political, humanitarian and security situation in Darfur, including detailed reporting on incidents of violence and attacks against civilians, including sexual and gender-based violence, by whomsoever perpetrated;

(ii) information on violations of the Status of Forces Agreement, including those involving attacks or threats of attack on UNAMID, violations of international humanitarian law perpetrated by any party to the conflict, as well as access restrictions and significant operational obstacles such as those related to customs clearances and visas;

(iii) developments and progress towards achievement of UNAMID's strategic priorities and benchmarks; (iv) progress in the implementation of the recommendations made in the Special Report, including the progress of reductions to UNAMIDs military and police component and its impact, including on protection needs and violations and abuses of human rights;

(v) developments and progress on strategically addressing the underlying drivers of inter-communal conflict and the action plan on the prevention and resolution of inter-communal conflict;

(vi) developments and progress in addressing the challenges facing UNAMID;

(vii) enhanced, detailed and full information on abuses and violations of human rights, including those committed against women and children and violations of international humanitarian law;

(viii) developments regarding UNAMID's support for local conflict resolution mechanisms, including progress regarding the full and effective participation of women; and

(ix) on the implementation of this resolution;

#### Sudan: SG and the Chairperson of the African Commission to provide written assessment Resolution 2363 (2017) of 29 June 2017

Para.6: Requests the Secretary-General and the Chairperson of the African Commission, in consultation with UNAMID, to provide a written assessment by 1 January 2018 on the following: (i) progress in implementing phase one of the reconfiguration recommended in the Special Report;

(ii) the impact of the phase one reductions on the areas that UNAMID has withdrawn from, including protection needs, violations and abuses of human rights and violations of international humanitarian law, and the ability for relief actors to provide humanitarian assistance;

(iii) the Government of Sudan's cooperation with UNAMID, including ensuring that UNAMID has unfettered freedom of movement and the ability to facilitate the delivery of humanitarian assistance throughout Darfur and the flexibility to open and close UNAMID operating bases, as necessary, including the establishment of a temporary operating base in Golo, and the ability for UNAMID's mandated forces to return, without impediments or obstacles, to areas throughout Darfur, including to areas that it has withdrawn from;

(iv) the removal of bureaucratic hindrances to UNAMID, including with regard to customs clearances and visas;

(v) whether the conditions on the ground remain conducive to further reductions;

The joint assessment is expected to be issued by <u>2 January 2018</u>.

Resolution 2340 (2017) of 8 February 2017

Para.2: Requests the Panel of Experts to provide to the Committee a first report on its activities no later than 12 August 2017, and, after discussion with the Committee, a final report to the Council no later than 12 January 2018 with its findings and recommendations;

The PoE final report dated 28 December 2017 (S/2017/1125) is before the Security Council.

#### UNOWAS: SG report to SC

#### PSC letter of 29 December 2016 (S/2016/1129)

Second para: The members of the Security Council concur with the recommendation contained in your second report on UNOWAS (S/2016/1072) to extend its mandate, as set forth in the annex to this letter, for a further period of three years, from 1 January 2017 to 31 December 2019. The members of the Council request that you report to the Council every six months on the fulfilment by UNOWAS of its mandate.

# Colombia: Verification Mission to, on a temporary basis, participate in and coordinate the work of the Monitoring and Verification Mission as outlined in the Joint Communiqué of the Government of Colombia and the ELN

Para.2: Decides that the United Nations Verification Mission established in resolution 2366 (2017) shall, on a temporary basis until 9 January 2018, participate in and coordinate the work of the MVM, as outlined in the Joint Communiqué, in order to:

(i) Verify compliance with the temporary, bilateral, national ceasefire with the ELN at the national, regional and local level;

(ii) Endeavour to prevent incidents through enhanced coordination between the parties and resolution of disagreements;

- (iii) Enable timely response by the parties to incidents;
- (iv) Verify and report publicly and to the parties on compliance with the ceasefire;

The mandate will end on <u>9 January 2018.</u>

#### Colombia: SG to report on Verification Mission

Para.8: Further requests the Secretary-General, based on the reporting of the Special Representative, to report to the Security Council on the implementation of the Verification Mission's mandate every 90 days after the start of its verification activities;

Para. 4: requests that the Special Representative of the Secretary-General and Head of the United Nations Assistance Mission to Iraq (UNAMI) promote, support and facilitate efforts regarding the repatriation or return of all Kuwaiti and third country nationals or their remains, and the return of Kuwaiti property, including the national archives, seized by Iraq, further requests the Secretary-General to report separately to the Security Council on these matters in his reports on the progress made towards the fulfilment of all UNAMI's responsibilities...;

Para.6: Requests the Panel of Experts to provide a midterm update to the Committee no later than 28 July 2017, and a final report no later than 28 January 2018 to the Security Council, after discussion with the Committee;

The PoE final report is expected to be provided no later than 28 January 2018.

#### UNRCCA: SG to inform SC about activities

PSC Letter of 15 May 2007 (S/2007/280)

I have the honour to inform you that your letter dated 7 May 2007 (S/2007/279) concerning your intention to establish a United Nations Regional Centre for Preventive Diplomacy in Ashgabat has been brought to the attention of the members of the Security Council. They take note of the information contained in your letter and the intention expressed therein, and invite you to inform them about the activities of the newly established Centre and its impact on the ground. They would welcome receiving such a report, for example, six months after the Centre becomes fully operational.

In the case of the presidency for the month of July ending its tenure on the Council that year, the task of coordinating the introduction of the report shall then devolve on the member of the Council next in English alphabetical order and who will not be leaving the Security Council that calendar year. The introduction to the report should continue to be approved by all members of the Council who served on the Council during the reporting period. The introduction, which should not exceed 10,000 words, may contain, inter alia, a brief description of the key activities and trends, and the nature of decisions taken by the Security Council during the period covered by the report. The introduction shall be completed no later than 31 January so as to allow the Securitate enough time for translation.

The introduction to the annual report is expected to be completed no later than 31 January 2018.

#### WMD: 1540 Committee annual POW

Resolution 2325 (2016) of 15 December 2016
