AFRICA

Burundi: SG reports on the situation in Burundi

S/PRST/2017/13 of 2 August 2017

Antepenultimate para: The Security Council recalls its request [in para.19 of resolution 2303 (2016) of 29 July 2016] to the Secretary-General to report to the Security Council on the situation in Burundi every three months, to be reviewed after one year, including on any public incidents of incitements to hatred and violence, and changes to the situation on the ground, and *further requests* the Secretary-General to provide written reports immediately to the Security Council, as necessary, on grave security incidents, violations of international humanitarian law and violations or abuses of human rights, as applicable, of which the United Nations in Burundi has knowledge, whoever perpetrates them.

The Secretary-General is expected to report in November 2018.

CAR: MINUSCA mandate

<u>Resolution 2387 (2017) of 15 November 2017</u> Para.31: Decides to extend the mandate of MINUSCA until 15 November 2018;

The mandate will expire on 15 November 2018.

CAR: French forces mandate in support of MINUSCA

Resolution 2387 (2017) of 15 November 2017

Para.65: Authorises French armed forces, within the provisions of their existing bilateral agreement with the CAR and the limits of their capacities and areas of deployment, at the request of the Secretary-General, to use all the means to provide operational support to elements of MINUSCA when under serious threat, from the date of adoption of this resolution, and requests France to ensure reporting to the Council on the implementation of this mandate and to coordinate its reporting with that of the Secretary-General referred to in paragraph 67 of this resolution;

The mandate will expire on 15 November 2018.

Central African region: SG reports on UNOCA, including on the situation in the Lake Chad region

Resolution 2349 (2017) of 31 March 2017

Para.34: Requests the Secretary-General to produce a written report within five months on the United Nations' assessment of the situation in the Lake Chad Basin Region as it relates to elements of this resolution, particularly regarding the progress made and remaining challenges, and possible measures for consideration, including with respect to achieving greater coherence of efforts in the context of overlapping regional strategies, and thereafter to include these elements in regular reporting by UNOCA and UNOWAS.

S/PRST/2018/17 of 10 August 2018

Last para.: The Security Council requests the Secretary-General to provide a written report to it on the situation in Central Africa and UNOCA's activities, including on the situation in the Lake Chad region as requested in resolution 2349 (2017), by 30 November 2018 and every six months thereafter.

The report of the Secretary-General is expected to be issued in November 2018.

DRC: SG to update SC on progress towards 23 December 2018 elections, including implementation of election benchmarks and obstacles to implementation of the 31 December 2016 agreement

Resolution 2409 (2018) of 27 March 2018

Para.61: Requests the Secretary-General to update the Security Council in writing every 30 days on political and technical progress towards 23 December 2018 elections, including benchmarks laid out in paragraph 7 above and obstacles to the implementation of the 31 December 2016 agreement, when no regular reports are due;

The report of the Secretary-General is expected to be issued in November 2018.

Guinea-Bissau: SG to submit assessment of the Mission including options for possible reconfiguration of UN in-country presence and re-prioritization of tasks

Resolution 2404 (2018) of 28 February 2018

Para.28: Requests the Secretary-General to provide an oral update within 3 months on the political and security situation in Guinea Bissau and its preparation for elections, and submit to the Security Council regular reports every six months on the implementation of this resolution, and within 9 months submit the Secretary-General's assessment of the Mission including options for a possible reconfiguration of the United Nations presence in the country and re-prioritization of tasks, and to submit a report within six months, with a briefing to the Committee established pursuant to its resolution 2048 (2012), on the progress made with regards to the stabilization of the country and restoration of constitutional order and recommendations on the continuation of the sanctions regime in the post-election environment, in line with paragraph 12 of resolution 2048 (2012);

The report of the Secretary-General is expected to be issued in November 2018.

Libya: UNSMIL: SG to report to SC on the implementation of resolution 2434 (2018) Resolution 2434 (2018) of 13 September 2018

Para.7: Requests the Secretary-General to continue to report to the Security Council on the implementation of this resolution at least every 60 days;

The Secretary-General is expected to report in November 2018.

Libya: Sanctions: Committee reports

Resolution 1970 (2011) of 26 February 2011

Para.24: Decides to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council (herein "the Committee"), to undertake to following tasks:

(e) To report within thirty days to the Security Council on its work for the first report and thereafter to report as deemed necessary by the Committee.

The Committee Chair is expected to report in November 2018.

Libya: Sanctions: Extension of authorizations provided by and measures imposed by resolution 2146 (2014) (measures in relation to attempts to illicitly export crude oil) Resolution 2362 (2017) of 29 June 2017

Para.2: Decides to extend until 15 November 2018 the authorizations provided by and the measures imposed by resolution 2146 (2014), and decides further that the authorisations provided by and the measures imposed by that resolution shall apply with respect to vessels loading, transporting, or discharging petroleum, including crude oil and refined petroleum products, illicitly exported or attempted to be exported from Libya;

The mandate will expire on 15 November 2018.

Libya: Sanctions: Panel of Experts mandate

Resolution 2362 (2017) of 29 June 2017

Para.13: Decides to extend until 15 November 2018 the mandate of the Panel of Experts (the Panel), established by paragraph 24 of resolution 1973 (2011) and modified by resolutions 2040 (2012), 2146 (2014), 2174 (2014), and 2213 (2015) and decides that the Panel's mandated tasks shall remain as defined in resolution 2213 (2015) and shall also apply with respect to the Measures updated in this resolution;

The mandate will expire on 15 November 2018.

Libya: ICC Prosecutor briefing

Resolution 1970 (2011) of 26 February 2011

Para.7: Invites the Prosecutor to address the Security Council within two months of the adoption of this resolution and every six months thereafter on actions taken pursuant to this resolution.

The ICC Prosecutor is expected to brief in November 2018.

Somalia: AU oral updates and written reports on the implementation of AMISOM's mandate

Resolution 2431 (2018) of 30 July 2018

Para.9: Requests the AU to keep the Security Council regularly informed, through the Secretary-General, on the implementation of AMISOM's mandate, including its reconfiguration in support of the transition plan, and any performance issues, such as effective command and control, responses to attacks on civilians, adequate equipment and information, which may adversely affect effective mandate implementation, and to report to the Council, through the provision of oral updates and no fewer than three written reports, every 120 days with the first written report not later than 15 November 2018, and further requests that the first written report contains a reconfiguration plan detailing the modalities of the reduction in the level of uniformed personnel set out in paragraph 5 of this resolution;

Somalia: Piracy: SG report on piracy

Resolution 2383 (2017) of 7 November 2017

Para.33: Requests the Secretary-General to report to the Security Council within eleven months of the adoption of this resolution on the implementation of this resolution and on the situation with respect to piracy and armed robbery at sea off the coast of Somalia;

The report of the Secretary-General dated 10 October 2018 (S/2018/903) is before the Security Council.

Somalia: Piracy: Authorizations for states and regional organizations in the fight against piracy and armed robbery at sea

Resolution 2383 (2017) of 7 November 2017

Para.14: Encourages Member States to continue to cooperate with Somali authorities in the fight against piracy and armed robbery at sea, notes the primary role of Somali authorities in the fight against piracy and armed robbery at sea off the coast of Somalia, and decides that, for a further period of 12 months from the date of this resolution to renew the authorizations as set out in paragraph 14 of resolution 2316 (2016) granted to States and regional organizations cooperating with Somali authorities in the fight against piracy and armed robbery at sea off the coast of Somalia, for which advance notification has been provided by Somali authorities to the Secretary-General;

The mandate will expire on 7 November 2018.

Somalia: Sanctions: Partial lifting of arms embargo

Resolution 2385 (2017) of 14 November 2017

Para.2: Decides to renew the provisions set out in paragraph 2 of resolution 2142 (2014) until 15 November 2018, and in that context reiterates that the arms embargo on Somalia shall not apply to deliveries of weapons, ammunition or military equipment or the provision of advice, assistance or training, intended solely for the development of the Somali National Security Forces, to provide security for the Somali people, except in relation to deliveries of the items set out in the annex of resolution 2111 (2013);

The mandate will expire on 15 November 2018.

Somalia: Sanctions: Authorization to inspect vessels bound to and from Somalia Resolution 2385 (2017) of 14 November 2017

Para.29: Expresses concern that the charcoal trade provides significant funding for Al-Shabaab, and in that context reiterates paragraphs 11 to 21 of resolution 2182 (2014), and further decides to renew the provisions set out in paragraph 15 of resolution 2182 (2014) until 15 November 2018;

The authorization will expire on 15 November 2018.

Somalia: Sanctions: Somalia/Eritrea Monitoring Group mandate review Resolution 2385 (2017) of 14 November 2017

Para.46: Decides to extend until 15 December 2018 the mandate of the Somalia and Eritrea SEMG as set out in paragraph 13 of resolution 2060 (2012) and updated in paragraph 41 of resolution 2093 (2013), and expresses its intention to review the mandate and take appropriate action regarding the further extension no later than 15 November 2018;

The Security Council is expected to take action no later than <u>15 November 2018.</u>

Somalia: Sanctions: Somalia/Eritrea Monitoring Group two final reports to SC, on focusing on Somalia, the other on Eritrea

Resolution 2385 (2017) of 14 November 2017

Para.48: Requests the SEMG to provide monthly updates to the Committee, and a comprehensive midterm update, as well as to submit, for the Security Council's consideration, through the Committee, two final reports; one focusing on Somalia, the other on Eritrea by 15 October 2018, covering all the tasks set out in paragraph 13 of resolution 2060 (2012) and updated in paragraph 41 of resolution 2093 (2013) and paragraph 15 of resolution 2182 (2014);

The final reports are expected to be provided in November 2018.

Somalia: Sanctions: 751/1907 Committee (Somalia/Eritrea) briefings to SC

Resolution 1844 (2008) of 20 November 2008

Para.11: Decides further to expand the mandate of the Committee as set out in resolution 751(1992) to include the following tasks:

(g) to report at least every 120 days to the Security Council on its work and on the implementation of this resolution, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraphs 1, 3 and 7 above.

The Committee chair is expected to brief in November 2018.

Sudan/South Sudan: UNISFA mandate

Resolution 2416 (2018) of 15 May 2018

Para 1: Decides to extend until 15 November 2018 the mandate of UNISFA as set out in paragraph 2 of resolution 1990 (2011) and acting under Chapter VII of the Charter of the United Nations, further decides to extend until 15 November 2018 the tasks of UNISFA as set out in paragraph 3 of resolution 1990 (2011);

The mandate will expire on <u>15 November 2018.</u>

Peace and security in Africa: SG to report to SC on activities of the Force conjointe du G5 Sahel

Resolution 2391 (2017) of 8 December 2017

Para.33: Requests the Secretary-General, in close coordination with the G5 Sahel States and the African Union, to report to the Security Council on the activities of the FC-G5S, five months after the adoption of this resolution and then every six months, focusing: (i) on progress in the operationalization of the FC-G5S, (ii) on international support granted to the FC-G5S and possible measures to enhance its efficiency,

(iii) on implementation of the technical agreement, including through a detailed outline of the support provided by MINUSMA to the FC-G5S, an assessment of its potential impact on MINUSMA as well as the provision of benchmarks to indicate the level of operationalization of the FC-G5S at which MINUSMA's logistical and operational support may be gradually withdrawn,

(iv) on challenges encountered by the FC-G5S and possible measures for further consideration,

(v) on implementation by the G5 Sahel States of the compliance framework, the HRDDP, as well as on ways to mitigate any adverse impact of the military operations of the FC-G5S on the civilian population, including on women and children;

The report of the Secretary-General is expected to be issued in November 2018.

AMERICAS

Haiti: MINUJUSTH: SG report on implementation of resolution 2410 (2018) Resolution 2410 (2018) of 10 April 2018

Para.4: Requests the Secretary-General to report to the Council on the implementation of this resolution, including any instances of mandate implementation failures and measures taken to address these, in reports every 90 days starting from 1 June 2018;

The report of the Secretary-General is expected to be issued in November 2018.

ASIA/MIDDLE EAST

Iraq: SG reports on UNAMI

Resolution 2421 (2018) of 14 June 2018

Para.6: Requests the Secretary-General to report to the Council every three months on the progress made towards the fulfilment of all UNAMI's responsibilities, including actions taken in response to the independent external assessment;

The report of the Secretary-General dated 31 October 2018 (S/2018/975) is before the Security Council.

Iraq/Kuwait: missing persons and return of property

Resolution 2107 (2013) of 27 June 2013

Para. 4: requests that the Special Representative of the Secretary-General and Head of the United Nations Assistance Mission to Iraq (UNAMI) promote, support and facilitate efforts regarding the repatriation or return of all Kuwaiti and third country nationals or their remains, and the return of Kuwaiti property, including the national archives, seized by Iraq, further requests the Secretary-General to report separately to the Security Council on these matters in his reports on the progress made towards the fulfilment of all UNAMI's responsibilities...;

The report of the Secretary-General dated 31 October 2018 (S/2018/976) is before the Security Council.

Iraq: Special Adviser to complete reports on the Investigative Team's activities and present them to the SC

Resolution 2379 (2017) of 21 September 2017

Para.15: Requests the Special Adviser to complete the first report of the Team's activities, within 90 days of the date on which it commences its activities, as notified by the Secretary-General, and to complete subsequent reports every 180 days thereafter, and requests the Special Adviser to present these reports to the Security Council;

SG letter of 17 August 2018 (S/2018/773)

Penultimate para.: In this regard, and following the mission of the Special Adviser to Iraq, I have the honour to notify the Security Council that the Investigative Team will begin its work on 20 August 2018.

The report is expected to be provided in November 2018.

Middle East: The situation in the Middle East, including the Palestinian question Resolution 1322 (2000) of 7 October 2000

Para.7: Invites the Secretary-General to continue to follow the situation and to keep the Security Council informed.

Middle East (Lebanon/UNIFIL): SG reports on implementation of resolution 1701 (2006) Resolution 2433 (2018) of 30 August 2018

Para.25: Requests the Secretary-General to continue to report to the Council on the implementation of resolution 1701 (2006), every four months, or at any time as he deems appropriate, and to include in his reporting a prompt and detailed breakdown of all resolution 1701 (2006) violations, prompt and detailed reports on violations of the sovereignty of Lebanon, prompt and detailed reports on the restrictions to UNIFIL's freedom of movement, an annex on the implementation on the arms embargo, reports on specific areas where UNIFIL does not access and on the reasons behind these restrictions, potential risks to the cessation of hostilities and UNIFIL's response as well as reports on the implementation of the recommendations of the 2016–2017 Strategic review and on additional identified efficiencies to most appropriately fulfil its mandated tasks; requests the Secretary-General to continue to provide concrete and detailed information on the aforementioned issues to the Council, in line with changes

The report of the Secretary-General is expected to be issued in November 2018.

Middle East (Syria): OPCW DG to report to SC (through SG) on impl. of resolution 2118 (2013) Resolution 2118 (2013) of 27 September 2013

Para.12: Decides to review on a regular basis the implementation in the Syrian Arab Republic of the decision of the OPCW Executive Council of 27 September 2013 and this resolution, and requests the Director-General of the OPCW to report to the Security Council, through the Secretary-General, who shall include relevant information on United Nations activities related to the implementation of this resolution, within 30 days and every month thereafter, and requests further the Director-General of the OPCW and the Secretary-General to report in a coordinated manner, as needed, to the Security Council, non-compliance with this resolution or the OPCW Executive Council decision of 27 September 2013.

The report is expected to be presented in November 2018.

Middle East (Syria): SG to report on implementation of resolutions 2139 (2014), 2165 (2014), 2191 (2014), 2258 (2015), 2332 (2016) and 2393 (2017)

Resolution 2139 (2014) of 22 February 2014

Para.17: Requests the Secretary-General to report to the Council on the implementation of this resolution by all parties in Syria, in particular paragraphs 2 through 12, in 30 days of its adoption and every 30 days thereafter, and upon receipt of the Secretary-General's report, expresses its intent to take further steps in the case of non-compliance with this resolution;

Resolution 2393 (2017) of 19 December 2017

Para.6: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all relevant parties in Syria, within the framework of its reporting on resolutions 2139 (2014), 2165 (2014), 2191 (2014), 2258 (2015) and 2332 (2016) and further requests the Secretary-General to include in his monthly reports overall trends in UN cross-line and cross-border humanitarian access, and more detailed information on the humanitarian assistance delivered through UN humanitarian cross-border operations as authorized by UNSCR 2165 (2014), including on the number of beneficiaries, locations of aid deliveries at district-level, and the volume and nature of items delivered;

Middle East (Syria): SG to report to SC on the implementation of resolution 2401 (2018) and compliance by parties

Resolution 2401 (2018) of 24 February 2018

Para.12: Requests the Secretary-General to report to the Council on the implementation of this resolution, and on compliance by all relevant parties in Syria, within 15 days of adoption of this resolution and thereafter within the framework of its reporting on resolutions 2139 (2014), 2165 (2014), 2191 (2014), 2258 (2015), 2332 (2016) and 2393 (2017);

The report of the Secretary-General is expected to be issued in November 2018.

Middle East (Syria): SG report on the implementation of resolution 2268 (2016)

Resolution 2268 (2016) of 26 February 2016

Para.10: Requests the Secretary-General to report to the Council on the implementation of this resolution, including by drawing on information provided by the ISSG ceasefire taskforce, and on resolution 2254 (2015), within 15 days of the adoption of this resolution and <u>every 30 days</u> thereafter;

The Secretary-General is expected to report in November 2018.

Middle East (Yemen): SG to report on the implementation of resolution 2201 (2015) and on developments in Yemen

Resolution 2201 (2015) of 15 February 2015

Para.13: Requests the Secretary-General to report on the implementation of this resolution, and to continue to report on developments in Yemen, including on the implementation of the Gulf Cooperation Council Initiative and its Implementation Mechanism, the outcomes of the comprehensive National Dialogue conference, and the Peace and National Partnership Agreement and its security annex within 15 days after the date of adoption of this resolution and every 60 days thereafter;

The Secretary-General is expected to report in November 2018.

EUROPE

BiH: EUFOR ALTHEA authorisation

Resolution 2384 (2017) of 7 November 2017

Para.3: Authorizes the Member States acting through or in cooperation with the EU to establish for a further period of twelve months, starting from the date of the adoption of this resolution, a multinational stabilization force (EUFOR ALTHEA) as a legal successor to SFOR under unified command and control, which will fulfil its missions in relation to the implementation of Annex 1-A and Annex 2 of the Peace Agreement in cooperation with the NATO Headquarters presence in accordance with the arrangements agreed between NATO and the EU as communicated to the Security Council in their letters of 19 November 2004, which recognize that EUFOR ALTHEA will have the main peace stabilization role under the military aspects of the Peace Agreement;

The mandate will expire on 7 November 2018

BiH: Authorization of NATO Headquarters

Resolution 2384 (2017) of 7 November 2017

Para.4: Decides to renew the authorization provided by paragraph 11 of its resolution 2183 (2014) for a further period of twelve months starting from the date of adoption of this resolution;

The authorization will expire on 7 November 2018.

BiH: Reports of High Representative to SC thru SG

Resolution 2183 (2014) of 11 November 2014

Para.20: Also requests the Secretary-General to continue to submit to the Council reports from the High Representative, in accordance with annex 10 of the Peace Agreement and the conclusions of the Peace Implementation Conference held in London on 4 and 5 December 1996 (S/1996/1012), and later Peace Implementation Conferences, on the implementation of the Peace Agreement and in particular on compliance by the parties with their commitments under that Agreement

The report of the High Representative dated 17 October 2018 (S/2018/974) is before the Security Council.

BiH: EUFOR ALTHEA/NATO reports to SC

Resolution 2183 (2014) of 11 November 2014

Para.18: Requests the Member States acting through or in cooperation with the EU and the Member States acting through or in cooperation with NATO to report to the Council on the activity of EUFOR ALTHEA and NATO Headquarters presence respectively, through the appropriate channels and at least at <u>six-monthly intervals</u>;

UNMIK: SG report

Resolution 1244 (1999) of 10 June 1999

Para.20: Requests the Secretary-General to report to the Council at regular intervals on the implementation of this resolution, including reports from the leaderships of the international civil and security presences, the first reports to be submitted within 30 days of the adoption of this resolution.

The report of the Secretary-General is expected to be issued in November 2018.

OTHER

Residual Mechanism: Annual report

Resolution 1966 (2010) of 22 December 2010

Para.16: Requests the President of the Mechanism to submit an annual report to the Security Council and to the General Assembly, and the President and the Prosecutor of the Mechanism to submit six-monthly reports to the Security Council on the progress of the work of the Mechanism;

The letter from the IRMCT President dated 1 August 2018 (S/2018/569) is before the Security Council.

Non-proliferation/DPRK: Sanctions: 1718 Committee reports

Resolution 1718 (2006) of 14 October 2006

Para.12: Decides to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council, to undertake the following tasks:

(g) To report at least every 90 days to the Security Council on its work, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraph 8 above.

The Chair of the Committee is expected to report in November 2018.

Maintenance of international peace & security: SG report on trafficking in persons in armed conflict

Resolution 2388 (2017) of 21 November 2017

Para.34: Requests the Secretary-General to follow-up on the implementation of this resolution and report back to the Security Council on progress made within 12 months;

The report of the Secretary-General is expected to be issued in November 2018.

United Nations peacekeeping operations: Police Commissioners: SG report on policing Resolution 2382 (2017) on 6 November 2017

Para.16: Requests the Secretary-General to provide a report by the end of 2018, including on: (a) Implications for the delivery of policing mandates stemming from any changes to the United Nations Secretariat's Peace and Security Architecture;

(b) Strengthening United Nations Policing's operational and policy coherence within the United Nations system;

(c) Improving United Nations capability, accountability and transparency on United Nations Policing;

(d) Planning for strategic police generation gaps and key skill sets;

(e) Ensuring coherence of relevant United Nations Policing initiatives, in order to improve mission transitions and timely exits;

(f) Strengthening partnerships between the United Nations and international, regional and subregional organizations in accordance with Chapter VIII of the United Nations Charter, in the areas of policing.
