### TENTATIVE FORECAST OF THE PROGRAMME OF WORK OF THE SECURITY COUNCIL FOR THE MONTH OF DECEMBER 2021

#### **AFRICA**

### Central African region: SG reports on UNOCA, including on the situation in the Lake Chad region

Resolution 2349 (2017) of 31 March 2017

Para.34: Requests the Secretary-General to produce a written report within five months on the United Nations' assessment of the situation in the Lake Chad Basin Region as it relates to elements of this resolution, particularly regarding the progress made and remaining challenges, and possible measures for consideration, including with respect to achieving greater coherence of efforts in the context of overlapping regional strategies, and thereafter to include these elements in regular reporting by UNOCA and UNOWAS.

#### S/PRST/2018/17 of 10 August 2018

Last para.: The Security Council requests the Secretary-General to provide a written report to it on the situation in Central Africa and UNOCA's activities, including on the situation in the Lake Chad region as requested in resolution 2349 (2017), by 30 November 2018 and every six months thereafter.

#### S/PRST/2020/12 of 4 December 2020

Last para.: Recalling its intention to review its request to the Secretary-General to report on the situation in Burundi every three months, as expressed in presidential statement S/2017/13, and noting that the Secretary-General's Special Envoy to Burundi completed his assignment on 30 November 2019, the Security Council requests the Secretary-General to cease his periodic reporting on the situation in Burundi and looks forward to the Secretary-General covering Burundi as part of his regular reporting on the Great Lakes region and Central Africa.

The report of the Secretary-General dated 26 November 2021 (S/2021/975) is before the Security Council.

#### **DRC: MONUSCO mandate**

Resolution 2556 (2020) of 18 December 2020

Para. 55: Requests the Secretary-General to report to the Council every three months on the situation in the DRC, including progress towards the strengthening of State institutions, key governance and security reforms, and on the implementation of MONUSCO's mandate, including [...]

The report of the Secretary-General is expected to be issued in December 2021.

#### DRC: Sanctions: Group of Experts mid-term and final reports

Resolution 2582 (2021) of 29 June 2021

Para. 6: Calls for enhanced cooperation between all States, particularly those in the region, and the Group of Experts and requests the Group of Experts to provide to the Council, after discussion with the Committee, a mid-term report no later than 30 December 2021, and a final report no later than 15 June

2022, as well as submit monthly updates to the Committee, except in the months where the mid-term and final reports are due;

The GoE mid-term report is expected to be presented no later than 30 December 2021.

#### Libya: Sanctions: Panel of Experts interim and final reports

Resolution 2571 (2021) of 16 April 2021

Para. 13: Decides that the Panel shall provide to the Council an interim report on its work no later than 15 December 2021, and a final report to the Council, after discussion with the Committee, no later than 15 June 2022 with its findings and recommendations;

The PoE interim report is expected to be presented no later than 15 December 2021.

### Mali: SG reports on MINUSMA on the implementation of resolution 2584 (2021) Resolution 2584 (2021) of 29 June 2021

Para. 61: Requests the Secretary-General to report to the Security Council every three months after the adoption of this resolution on the implementation of this resolution, focusing on: (i) progress in achieving the priority measures referenced in paragraphs 4 and 15, and whether and how the mission's activities have contributed toward achieving the mission's strategic priorities referenced in paragraph 21 and priority tasks referenced in paragraph 30, (ii) coordination, exchange of information and, when applicable, mutual operational and logistical support, between MINUSMA, the MDSF, the FC-G5S, the French Forces and the European partners, including Task Force Takuba, and the European Union missions in Mali, (iii) measures to improve external communication of the mission;

#### S/PRST/2020/10 of 15 October 2020

Last para.: The Security Council also requests MINUSMA, within its mandate and existing resources, to support the political transition in Mali, particularly by exercising good offices, confidence-building and facilitation at the national and local levels, and by supporting, together with the United Nations country team, the holding of inclusive, free, fair, transparent, and credible elections, conducted in a peaceful environment, including through the provision of technical assistance and security arrangements, consistent with the provisions of the Agreement. It requests the Secretary General to include in its quarterly reports updates on how MINUSMA supports the political transition.

#### Resolution 2590 (2021) of 30 August 2021

Para. 5: Reaffirms the reporting and review provisions as set out in resolution 2374 (2017) and requests the Secretary-General to include in his December 2021 report on MINUSMA an update on the measures taken to ensure that sanctioned individuals do not benefit from any support from United Nations entities deployed in Mali;

The report of the Secretary-General is expected to be issued in <u>December 2021.</u>

# Mali: Report by France on implementation of mandate to support MINUSMA Resolution 2584 (2021) of 29 June 2021

Para. 43: Authorizes French forces, within the limits of their capacities and areas of deployment, to use all necessary means until the end of MINUSMA's mandate as authorized in this resolution, to intervene in support of elements of MINUSMA when under imminent and serious threat upon request of the Secretary-General, and requests France to report to the Council on the implementation of this mandate in Mali and to coordinate its reporting with the reporting by the Secretary-General referred to in paragraph 61 below;

Mali: SG letter on MINUSMA operations, performance and implementation of the integrated strategic framework

Resolution 2584 (2021) of 29 June 2021

Para. 62: Further requests the Secretary-General, addressing perspectives from all relevant actors, including the SRSG, in consultation with the Force Commander, to provide every six months the Security Council with a letter exclusively and thoroughly focusing on mission-wide performance and challenges by providing information on: (i) progress in mission operations, security challenges, and coordination between security actors, including discussions in the Instance de Coordination au Mali. (ii) overall performance, including implementation of the Adaptation Plan, roll out of the Integrated Peacekeeping Performance and Accountability Framework (IPPAF) and the Comprehensive Planning Performance Assessment System (CPPAS), the improvement and the performance of the Casualtv Evacuation System, rotations of uniformed personnel, on the basis of the methodology referred to in paragraph 47, including information on undeclared caveats, declining to participate in or undertake patrols and their impact on the mission, and how the reported cases of under-performance are addressed, (iii) integration of all mission's components, including an update on the implementation of the integrated strategic framework referred to in paragraph 26 above, encouraging that this framework also includes a transition plan in line with the SG's roadmap of 25 March 2021 with a view to handing over relevant tasks in the long-term, in a phased, coordinated and deliberate manner, to Malian authorities, the UNCT and other UN entities based on their mandates and comparative advantages as well as on a mapping of capabilities and gaps, and a resource mobilization strategy that involves the full range of multilateral and bilateral partners;

The Secretary-General is expected to report in <u>December 2021.</u>

#### Somalia: AMISOM mandate

Resolution 2568 (2021) of 12 March 2021

Para. 10: Decides to authorise the Member States of the African Union to maintain the deployment of 19,626 uniformed AMISOM personnel until 31 December 2021, inclusive of a minimum of 1,040 AMISOM police personnel including five Formed Police Units, as well as 70 AMISOM civilian personnel supported by the UN Support Office in Somalia to conduct tasks in line with the STP, and the phased handover of security to Somali security forces commencing in 2021;

# Somalia: Piracy: Authorizations for states and regional organizations in the fight against piracy and armed robbery at sea

Resolution 2554 (2020) of 4 December 2020

Para. 14: Decides that, for a further period of 12 months from the date of this resolution to renew the authorizations as set out in paragraph 14 of resolution 2500 (2019) granted to States and regional organizations cooperating with Somali authorities in the fight against piracy and armed robbery at sea off the coast of Somalia, for which advance notification has been provided by Somali authorities to the Secretary-General;

The mandate will expire on 4 December 2021.

### South Sudan: SG report on implementation of the UNMISS mandate and obstructions Resolution 2567 (2021) of 12 March 2021

Para. 29: Requests the Secretary-General to report to the Security Council on implementation of the UNMISS mandate and the obstructions UNMISS encounters in doing so in a comprehensive written report to be submitted within 90 days of the date of adoption of this resolution, every 90 days thereafter, and underscores that such reporting should include attention to: [...]

The report of the Secretary-General is expected to be issued in <u>December 2021.</u>

### South Sudan: Sanctions: Panel of Experts interim and final reports Resolution 2577 (2021) of 28 May 2021

Para. 17: Decides to extend until 1 July 2022 the mandate of the Panel of Experts as set out in paragraph 19 of resolution 2428 (2018), and decides that the Panel of Experts should provide to the

Council, after discussion with the Committee, an interim report by 1 December 2021, a final report by 1 May 2022, and except in months when these reports are due, updates each month;

The PoE interim report is expected to be presented by 1 December 2021.

### Sudan: SG to report on the implementation of UNITAMS mandate

Resolution 2579 (2021) of 3 June 2021

Para. 19: Requests the Secretary-General to report to the Security Council every 90 days on the implementation of the UNITAMS mandate, and on progress made against the benchmarks and indicators in line with paragraph 7 of this resolution;

Para. 12: Requests that UNITAMS integrates gender considerations as a cross-cutting issue throughout its mandate and assists the Government of Sudan in ensuring the full, equal and meaningful participation of women at all levels of peace and political processes, and in all social and economic aspects of life, and reaffirms the importance of gender expertise, including the deployment of gender and women protection advisors, gender analysis, including the collection and use of sex- and age-disaggregated data, and capacity-strengthening in executing the mission mandate in a gender-responsive manner, and requests the Secretary-General to include gender analysis in the reports requested in paragraph 19 of this resolution;

#### Joint briefings by 3 Committees (CTC, 1267 & 1540)

### ISIL (Da'esh) and Al-Qaeda Sanctions: Monitoring Team mandate

Para. 94: Decides, in order to assist the Committee in fulfilling its mandate, as well as to support the Ombudsperson, to extend the mandate of the current New York-based Monitoring Team and its members, established pursuant to paragraph 7 of resolution 1526 (2004), for a further period of twenty four months from the expiration of its current mandate in December 2019, under the direction of the Committee with the responsibilities outlined in annex I, and requests the Secretary-General to make the necessary arrangements to this effect, and welcomes the restructuring under way in the Secretariat which will allow the Monitoring Team to receive and fully enjoy the benefits of the additional substantive and administrative staff and resources requested in paragraph 90 of resolution 2253 (2015) to effectively, safely, and in a timely manner fulfil its mandate, including with regard to duty of care in high-risk environments, under the direction of the Committee, a subsidiary organ of the Security Council, and requests further updates from the Secretariat by December 17 2017 on the restructuring;

The mandate will expire on 17 December 2021.

### ISIL (Da'esh) and Al-Qaeda Sanctions: Office of Ombudsperson mandate Resolution 2368 (2017) of 20 July 2017

undertakings or entities seeking to be removed from the ISIL (Da'esh) & Al-Qaida Sanctions List in an independent and impartial manner and shall neither seek nor receive instructions from any government, and further affirms that the Ombudsperson shall continue to present to the Committee observations and a recommendation on the delisting of those individuals, groups, undertakings or entities that have requested removal from the ISIL (Da'esh) & Al-Qaida Sanctions List through the Office of the Ombudsperson, either a recommendation to retain the listing or a recommendation that the Committee consider delisting;

Eighth para.: The Security Council underscores the importance it places on the safety and security of peacekeepers on the ground and the need for troop-and police- contributing countries to, ensure where appropriate, that all peacekeepers in the field are equipped, informed and trained to mitigate the threat posed by landmines, explosive remnants of war and improvised explosive devices. The Council requests the Secretary-General to provide the Security Council, no later than 15 December 2021, with an independent strategic review of United Nations peacekeeping operations' responses to improvised explosive devices, assessing capabilities and measures necessary to better mitigate this threat.
