DRC: SG reports on MONUSCO

Resolution 2612 (2021) of 20 December 2021

Para. 55: Requests the Secretary-General to report to the Council every three months including: (i) information on the situation in the DRC, including progress towards the strengthening of State institutions, key governance and security reforms; [...]

The report of the Secretary-General is expected to be issued in March 2022.

DRC: SG reports on implementation of the commitments under the PSC Framework Resolution 2612 (2021) of 20 December 2021
