#### AFRICA

### Central African region: SG reports on UNOCA, including on the situation in the Lake Chad region

#### Resolution 2349 (2017) of 31 March 2017

Para. 34: Requests the Secretary-General to produce a written report within five months on the United Nations' assessment of the situation in the Lake Chad Basin Region as it relates to elements of this resolution, particularly regarding the progress made and remaining challenges, and possible measures for consideration, including with respect to achieving greater coherence of efforts in the context of overlapping regional strategies, and thereafter to include these elements in regular reporting by UNOCA and UNOWAS.

#### S/PRST/2018/17 of 10 August 2018

Last para.: The Security Council requests the Secretary-General to provide a written report to it on the situation in Central Africa and UNOCA's activities, including on the situation in the Lake Chad region as requested in resolution 2349 (2017), by 30 November 2018 and every six months thereafter.

#### S/PRST/2020/12 of 4 December 2020

Last para.: Recalling its intention to review its request to the Secretary-General to report on the situation in Burundi every three months, as expressed in presidential statement S/2017/13, and noting that the Secretary-General's Special Envoy to Burundi completed his assignment on 30 November 2019, the Security Council requests the Secretary-General to cease his periodic reporting on the situation in Burundi and looks forward to the Secretary-General covering Burundi as part of his regular reporting on the Great Lakes region and Central Africa.

Para. 58: (b) Also requests the Secretary-General to provide the Council with: an evaluation, no later than May 2022, of the logistical support provided to CAR defence and security forces in line with paragraph 35 of this resolution, including by providing appropriate financial information; a mid-report by June 2022 on MINUSCA's overall effectiveness and configuration, to identify gaps in objectives and outcomes, in order to better achieve its mandate;

The Secretary-General is expected to report in May 2022.

#### CAR: SG reports on the situation in CAR and MINUSCA

Resolution 2605 (2021) of 12 November 2021

Para. 58: (a) Requests the Secretary-General to report to the Council on 15 February 2022, 15 June 2022 and 14 October 2022, including on: the situation in the CAR, including the security situation, the respect by all parties of the ceasefire, the political process, the implementation of the APPR, including efforts made by MINUSCA to support the ceasefire and DDRR process, progress on mechanisms and capacity to advance governance and fiscal management, and relevant information on the progress, promotion and protection of human rights and international humanitarian law and on the protection of civilians; violations of the Status of Forces Agreement and follow up on efforts to hold perpetrators accountable, including through joint investigations, as well as attacks, provocations and incitement to hatred and violence and disinformation campaigns against MINUSCA; the status of the implementation

of MINUSCA's mandated tasks, including instances in which MINUSCA was unable to reach civilians in response to POC alerts; force and police generation and deployment of all MINUSCA's constituent elements, and information on the progress in the implementation of the measures taken to improve MINUSCA's performance, including measures to ensure force effectiveness as outlined in paragraphs 37 to 45, as well as information on the implementation of the zero-tolerance policy on sexual exploitation and abuse as outlined in paragraphs 42 and 43; overall Mission performance, the Mission's implementation of the Integrated Peacekeeping Performance and Accountability Framework (IPPAF) and Comprehensive Planning and Performance Assessment System (CPAS); including information on undeclared caveats, declining to participate in or undertake patrols and their impact on the mission, and how the reported cases of under-performance are addressed; implementation, performance and necessity ahead of each phase of the reinforcements decided in resolution 2566 (2021) and recalled in this resolution;

The report of the Secretary-General is expected to be issued in June 2022.

#### CAR: France to report to SC on implementation of mandate to support MINUSCA Resolution 2605 (2021) of 12 November 2021

Para. 56: Authorises French armed forces, within the provisions of their existing bilateral agreement with the CAR and the limits of their capacities and areas of deployment, at the request of the Secretary-General, to use all the means to provide operational support to elements of MINUSCA when under serious threat, from the date of adoption of this resolution, and requests France to ensure reporting to the Council on the implementation of this mandate and to coordinate its reporting with that of the Secretary-General referred to in paragraph 58 of this resolution;

#### CAR: SG to provide a mid-term report on MINUSCA's overall effectiveness and configuration Resolution 2605 (2021) of 12 November 2021

Para. 58: (b) Also requests the Secretary-General to provide the Council with: an evaluation, no later than May 2022, of the logistical support provided to CAR defence and security forces in line with paragraph 35 of this resolution, including by providing appropriate financial information; a mid-report by June 2022 on MINUSCA's overall effectiveness and configuration, to identify gaps in objectives and outcomes, in order to better achieve its mandate;

The Secretary-General is expected to report in June 2022.

#### CAR: Sanctions: Panel of Experts midterm and final reports

Resolution 2588 (2021) of 29 July 2021

Para. 7: Requests the Panel of Experts to provide to the Council, after discussion with the Committee, a midterm report no later than 31 January 2022, a final report no later than 30 June 2022, and progress updates, as appropriate;

The PoE final report is expected to be provided no later than <u>30 June 2022</u>.

#### CAR: Sanctions: SG to conduct an assessment on progress achieved on key benchmarks Resolution 2588 (2021) of 29 July 2021

Para. 13: Requests the Secretary-General, in close consultation with MINUSCA, including UNMAS, and the Panel of Experts, to conduct, no later than 15 June 2022, an assessment on the progress achieved by the CAR authorities on the key benchmarks;

The Secretary-General is expected to report in June 2022.

#### **DRC: SG reports on MONUSCO**

Resolution 2612 (2021) of 20 December 2021

Para. 55: Requests the Secretary-General to report to the Council every three months including: (i) information on the situation in the DRC, including progress towards the strengthening of State institutions, key governance and security reforms; [...]

The report of the Secretary-General is expected to be issued in June 2022.

#### DRC: Sanctions: Group of Experts mid-term and final reports

Resolution 2582 (2021) of 29 June 2021

Para. 6: Calls for enhanced cooperation between all States, particularly those in the region, and the Group of Experts and requests the Group of Experts to provide to the Council, after discussion with the Committee, a mid-term report no later than 30 December 2021, and a final report no later than 15 June 2022, as well as submit monthly updates to the Committee, except in the months where the mid-term and final reports are due;

The GoE final report is expected to be provided no later than <u>15 June 2022</u>.

### Libya: UNSMIL: SG to report to SC on the implementation of resolution 2629 (2022)

Resolution 2629 (2022) of 29 April 2022

Para. 6: Requests the Secretary-General to report to the Security Council on the implementation of this resolution every 30 days up until 31 July 2022;

#### Resolution 2570 (2021) of 16 April 2021

Para. 19: Further requests that the Secretary-General includes updates on UNSMIL's support to the relevant Libyan authorities and institutions ahead of the upcoming elections, the implementation of the 23 October ceasefire agreement, the progress made by the LCMM, the deployment of UNSMIL ceasefire monitors in support, and criteria for their eventual departure, in his regular reporting and in any additional reports, as necessary;

The Secretary-General is expected to report in June 2022.

#### Libya: Sanctions: Panel of Experts interim and final reports

# Libya: Sanctions: Extension of authorizations as set out in resolution 2526 (2020) to inspect vessels bound to or from Libya which Member States have reasonable grounds to believe are carrying arms or related materiel to or from Libya

Resolution 2578 (2021) of 3 June 2021

Para. 1: Decides to extend the authorizations as set out in resolution 2526 (2020) for a further 12 months from the date of this resolution;

The authorizations will expire on <u>3 June 2022</u>.

#### Mali: MINUSMA mandate

<u>Resolution 2584 (2021) of 29 June 2021</u> Para. 17: Decides to extend the mandate of MINUSMA until 30 June 2022;

The mandate will expire on 30 June 2022.

#### Mali: French forces mandate

Resolution 2584 (2021) of 29 June 2021

Para. 43: Authorizes French forces, within the limits of their capacities and areas of deployment, to use all necessary means until the end of MINUSMA's mandate as authorized in this resolution, to intervene in support of elements of MINUSMA when under imminent and serious threat upon request of the Secretary-General, and requests France to report to the Council on the implementation of this mandate in Mali and to coordinate its reporting with the reporting by the Secretary-General referred to in paragraph 61 below;

The mandate will expire on 30 June 2022.

#### Mali: SG reports on MINUSMA on the implementation of resolution 2584 (2021)

Resolution 2584 (2021) of 29 June 2021

Para. 61: Requests the Secretary-General to report to the Security Council every three months after the adoption of this resolution on the implementation of this resolution, focusing on: (i) progress in achieving the priority measures referenced in paragraphs 4 and 15, and whether and how the mission's activities have contributed toward achieving the mission's strategic priorities referenced in paragraph 21 and priority tasks referenced in paragraph 30, (ii) coordination, exchange of information and, when applicable, mutual operational and logistical support, between MINUSMA, the MDSF, the FC-G5S, the French Forces and the European partners, including Task Force Takuba, and the European Union missions in Mali, (iii) measures to improve external communication of the mission;

#### S/PRST/2020/10 of 15 October 2020

Last para.: The Security Council also requests MINUSMA, within its mandate and existing resources, to support the political transition in Mali, particularly by exercising good offices, confidence-building and facilitation at the national and local levels, and by supporting, together with the United Nations country team, the holding of inclusive, free, fair, transparent, and credible elections, conducted in a peaceful environment, including through the provision of technical assistance and security arrangements, consistent with the provisions of the Agreement. It requests the Secretary General to include in its quarterly reports updates on how MINUSMA supports the political transition.

The report of the Secretary-General is expected to be issued in June 2022.

### Mali: Report by France on implementation of mandate to support MINUSMA

Resolution 2584 (2021) of 29 June 2021

Para. 43: Authorizes French forces, within the limits of their capacities and areas of deployment, to use all necessary means until the end of MINUSMA's mandate as authorized in this resolution, to intervene in support of elements of MINUSMA when under imminent and serious threat upon request of the Secretary-General, and requests France to report to the Council on the implementation of this mandate in Mali and to coordinate its reporting with the reporting by the Secretary-General referred to in paragraph 61 below;

### Mali: SG letter on MINUSMA operations, performance and implementation of the integrated strategic framework

Para. 62: Further requests the Secretary-General, addressing perspectives from all relevant actors, including the SRSG, in consultation with the Force Commander, to provide every six months the Security Council with a letter exclusively and thoroughly focusing on mission-wide performance and

challenges by providing information on: (i) progress in mission operations, security challenges, and coordination between security actors, including discussions in the Instance de Coordination au Mali, (ii) overall performance, including implementation of the Adaptation Plan, roll out of the Integrated Peacekeeping Performance and Accountability Framework (IPPAF) and the Comprehensive Planning Performance Assessment System (CPPAS), the improvement and the performance of the Casualty Evacuation System, rotations of uniformed personnel, on the basis of the methodology referred to in paragraph 47, including information on undeclared caveats, declining to participate in or undertake patrols and their impact on the mission, and how the reported cases of under-performance are addressed, (iii) integration of all mission's components, including an update on the implementation of the integrated strategic framework referred to in paragraph 26 above, encouraging that this framework also includes a transition plan in line with the SG's roadmap of 25 March 2021 with a view to handing over relevant tasks in the long-term, in a phased, coordinated and deliberate manner, to Malian authorities, the UNCT and other UN entities based on their mandates and comparative advantages as well as on a mapping of capabilities and gaps, and a resource mobilization strategy that involves the full range of multilateral and bilateral partners;

The Secretary-General is expected to report in June 2022.

#### Somalia: Sanctions: 751 Committee (Somalia) briefings to SC

Resolution 1844 (2008) of 20 November 2008

Para. 11: Decides further to expand the mandate of the Committee as set out in resolution 751(1992) to include the following tasks:

(g) to report at least every 120 days to the Security Council on its work and on the implementation of this resolution, with its observations and recommendations, in particular on ways to strengthen the effectiveness of the measures imposed by paragraphs 1, 3 and 7 above.

#### Resolution 2444 (2018) of 14 November 2018

Para. 55: Requests the Committee, in accordance with its mandate and in consultation with the Panel of Experts and other relevant United Nations entities, to consider the recommendations contained in the reports of the Panel of Experts and recommend to the Security Council ways to improve the implementation of and compliance with the Somalia arms embargo, the measures regarding the import and export of charcoal from Somalia, as well as implementation of the measures imposed by paragraphs 1, 3 and 7 of resolutions 1844 (2008) in response to continuing violations;

The Committee Chair is expected to report in June 2022.

#### South Sudan: SG report on implementation of the UNMISS mandate and obstructions Resolution 2625 (2022) of 15 March 2022

Para. 30: Requests the Secretary-General to report to the Security Council on implementation of the UNMISS mandate and the obstructions UNMISS encounters in doing so in a comprehensive written report to be submitted within 90 days of the date of adoption of this resolution, every 90 days thereafter, and underscores that such reporting should provide integrated, evidence-based and data-driven analysis, strategic assessments and frank advice to the Security Council and should include attention to: [...]

#### Sudan: UNITAMS mandate

Para. 1: Decides to extend the mandate of the United Nations Integrated Transition Assistance Mission in Sudan (UNITAMS) until 3 June 2022;

The mandate will expire on 3 June 2022.

#### Sudan: Sanctions: 1591 Committee reports

Resolution 1591 (2005) of 29 March 2005

Para. 3: Decides, in light of the failure of all parties to the conflict in Darfur to fulfil their commitments, (a) to establish, in accordance with rule 28 of its provisional rules of procedure, a Committee of the Security Council consisting of all the members of the Council (herein "the Committee"), to undertake to following tasks:

iv. to report at least every 90 days to the Security Council on its work.

The Committee Chair is expected to report in June 2022.

#### UNOWAS: SG reports to SC

#### PSC letter of 31 January (S/2020/85)

Second para: The members concur with the recommendation contained in your letter to extend the mandate of UNOWAS, as set forth in the annex to this letter, for a further period of three years, from 1 February 2020 to 31 January 2023. The members of the Council request that you report to the Council every six months on the fulfilment by UNOWAS of its mandate.

The report of the Secretary-General is expected to be issued in June 2022.

#### AMERICAS

#### Colombia: SG to report on Verification Mission

Resolution 2366 (2017) of 10 July 2017

Para. 8: Further requests the Secretary-General, based on the reporting of the Special Representative, to report to the Security Council on the implementation of the Verification Mission's mandate every 90 days after the start of its verification activities;

#### Resolution 2545 (2020) of 25 September 2020

Para. 1: Decides to extend, to 25 September 2021, the mandate of the Verification Mission and reporting requirements in accordance with its resolutions 2366 (2017), 2377 (2017), 2435 (2018), and 2487 (2019), headed by a Special Representative of the Secretary-General of the United Nations;

#### Resolution 2574 (2021) of 11 May 2021

Resolution 2585 (2021) of 9 July 2021

Para. 5: Requests the Secretary-General to brief the Council monthly and to provide a report on a regular basis, at least every 60 days, on the implementation of resolutions 2139 (2014), 2165 (2014), 2191 (2014), 2258 (2015), 2332 (2016), 2393 (2017), 2401 (2018), 2449 (2018), 2504 (2020), 2533 (2020) and this resolution and on compliance by all relevant parties in Syria and further requests the Secretary-General to include in his reports overall trends in United Nations cross-line operations, in particular on the implementation of the above mentioned activities on improving all modalities of humanitarian deliveries inside Syria and early recovery projects, and detailed information on the humanitarian assistance delivered through United Nations humanitarian cross-border operations, including the distribution mechanism, the number of beneficiaries, operating partners, locations of aid deliveries at district-level and the volume and nature of items delivered;

The report of the Secretary-General is expected to be issued in June 2022.

#### Middle East (Syria): SG report on the implementation of resolution 2268 (2016)

#### Resolution 2268 (2016) of 26 February 2016

Para. 7: Requests the Secretary-General to report to the Security Council on a monthly basis on progress regarding the implementation of this resolution, including on any obstructions to the effective operation of UNMHA caused by any party; and on resolution 2451 (2018), including on any non-compliance by any party;

The Secretary-General is expected to report in June 2022.

#### Middle East (Yemen): SG to present to SC a further review of UNMHA

Resolution 2586 (2021) of 14 July 2021

Para. 8: Further requests the Secretary-General to present to the Council a further review of UNMHA, at least one month before UNMHA's mandate is due to expire;

The report of the Secretary-General is expected to be issued in June 2022.

#### COUNTER-TERRORISM/NON-PROLIFERATION

Non-proliferation (Iran): SG reports on the implementation of resolution 2231 (2015) Note by the PSC of 16 January 2016

Para. 7: The Security Council requests that the Secretary-General report to the Security Council every six months on the implementation of resolution 2231 (2015). Prior to the public release of that report, the Security Council shall meet informally, normally at the expert level, to review the findings and recommendations contained in the report.

Facilitator's proposal as agreed on 17 March 2017

The report of the Secretary-General is expected to be issued in June 2022.

#### Non-proliferation (Iran): Joint Commission reports

Resolution 2231 (2015) of 20 July 2015

JCPOA Annex IV – Joint Commission para. 6.10.: The Joint Commission will report to the United Nations Security Council at least every 6 months on the status of the Procurement Working Group's decisions and on any implementation issues.

Facilitator's proposal as agreed on 17 March 2017

The Joint Commission is expected to report in June 2022.

#### Non-proliferation (Iran): Facilitator to brief the other members of the SC

Note by the PSC of 16 January 2016

Para. 3: To facilitate its work under resolution 2231 (2015), the Security Council shall select on an annual basis one member to serve as its facilitator for the functions specified in the present note. The facilitator shall brief the other members of the Council on its work and the implementation of the resolution every six months, in parallel with the report submitted by the Secretary-General in accordance with paragraph 7 below.

Facilitator's proposal as agreed on 17 March 2017

The Facilitator is expected to brief in June 2022.

# 1988 Committee: Sanctions: Emergency Relief Coordinator to brief the Council on the delivery of humanitarian assistance in Afghanistan

#### Resolution 2615 (2021) of 22 December 2021

Para. 2: Requests the Emergency Relief Coordinator to brief the Security Council every six months from the adoption of this resolution based on the delivery of humanitarian assistance in Afghanistan including on any available information regarding payments of funds to, or for the benefit of, designated individuals or entities, any diversion of funds by the same, risk management and due diligence processes in place, and any obstacles to the provision of such assistance, and further requests relevant providers to assist the Emergency Relief Coordinator in the preparation of such briefings by providing information relevant to paragraph 1 above within 60 days of any such provision;

The Emergency Relief Coordinator is expected to brief in June 2022.

#### Residual mechanism: Progress reports

#### Resolution 1966 (2010) of 22 December 2010

Para. 16: Requests the President of the Mechanism to submit an annual report to the Security Council and to the General Assembly, and the President and the Prosecutor of the Mechanism to submit six-monthly reports to the Security Council on the progress of the work of the Mechanism;
