# **UN Security Council in Review**

April 2022

## April 2022 at a Glance







Under the **Presidency of the United Kingdom**, the Security Council held **two signature events**, both under thematic agenda items:

A high-level briefing (11 April) on Maintenance of international peace and security, focusing on the implementation of resolution 2532 (2020), endorsing the Secretary-General's 2020 appeal for a global ceasefire to help unite efforts to fight COVID-19, and resolution 2565 (2021), calling for strengthened international cooperation for equitable and affordable access to COVID-19 vaccines in armed conflict situations. The Minister of State for South and Central Asia, North Africa, UN and the Commonwealth, and the Prime Minister's **Special Representative on Preventing** Sexual Violence in Conflict presided over the meeting.

• A high-level open debate (13 April) on Women and peace and security, focusing on accountability as prevention: ending cycles of sexual violence in conflict. The Minister of State for South and Central Asia, North Africa, UN and the Commonwealth, and the Prime Minister's Special Representative on Preventing Sexual Violence in Conflict presided over the meeting.

## **Key Topics**

Libya (19, 28, and 29), the Middle East (14, 26, and 29) and items relating to Ukraine (5, 11, and 19) were the most frequently considered country- or region-specific items in open and closed discussions, followed by the Middle East including the Palestinian question (19 and 25).

Other country or region-specific items considered by the Council included: **Colombia,** the **Great Lakes region**, **Kosovo**, Mali, Sudan and South Sudan (UNISFA), and Western Sahara (MINURSO). Council members also discussed Ethiopia, and the Sudan (Darfur) under other matters (AOB).

#### **Procedural notes**

On 5 April, the **President of Ukraine**, invited under rule 37 of the provisional rules of procedure, addressed the Council via videoconference. This was the first time in 2022 that a rule 37 invitee participated via videoconference. The **Secretary-General** delivered a statement at the start of the meeting. At the meeting an **audiovisual recording** was played in the Council Chamber provided by the delegation of Ukraine which was reflected in the verbatim record (S/PV.9011).

On 12 April, the **President of Colombia**, invited under rule 37, attended in person the **quarterly briefing on the peacebuilding process in Colombia**.

During the open debate on women and peace and security held on 13 April, **54 member states participated in person under rule 37**, the highest number of rule 37 invitees participating in-person in a meeting of the Council since January 2020.

In April, a new agenda item entitled "Maintenance of Peace and Security of Ukraine" was introduced. The first meeting under the item was held on 11 April, focusing on the role of women in the maintenance of peace and security in Ukraine and the impact of the conflict on women and children.

### Decisions and press statements

In April 2021, the Council adopted one resolution and issued no presidential statements.

On 29 April, the Council unanimously adopted resolution 2629 (2022), extending for 3 months the mandate of UNSMIL until 31 July 2022, requesting the Mission to implement the recommendation of the Independent Strategic Review of UNSMIL (S/2021/716), and deciding that the Mission should be led by a Special Representative of the Secretary-General based in Tripoli. This was the **fourth resolution** extending the mandate of UNSMIL since September 2021.

The Council issued **12 press statements** on the following topics: the **crash of a MONUSCO** helicopter in the Democratic Republic of the Congo (SC/14849), the **cross-border terrorist attacks by the Houthis against Saudi Arabia** on 20 March and 25 March (SC/14852), the **Yemen Truce Announcement** (SC/14853), the **attack against MONUSCO** in the Democratic Republic of the Congo (SC/14855), political developments and the humanitarian crisis in **Yemen** (SC/14861), the terrorist attacks on educational institutions in **Afghanistan** on 19 April (SC/14866), the string of terrorist attacks in **Afghanistan** on 21 April (SC/14879), the continued attacks in **Afghanistan** (SC/14880), the situation in the **Great Lakes region** (SC/14872), the terrorist attack in Karachi, **Pakistan** (SC/14873), recent violence in West Darfur, **Sudan** (SC/14878), and the Twenty-Fifth **Anniversary of Chemical Weapons Convention** (SC/14876).

#### Other activities

In April, Council members convened three Arria-formula meetings on the following topics: "**Threats to international peace and security emanating from military biological activities in regions across the globe**" convened by the Russian Federation (6 April), "**Conflict and hunger**" convened by Ireland (21 April), and "**Ensuring accountability for atrocities committed in Ukraine**" convened by Albania and France (27 April). All Arria-formula meetings in April were held in person.
