June 2023 at a Glance





Under the **Presidency of the United Arab Emirates**, the Security Council held **three signature events**, all under thematic agenda items:

•A briefing on Cooperation between the United Nations and regional and subregional organizations in maintaining international peace and security (8 June), focusing on cooperation with the League of Arab States (S/2023/407). The Minister of State of the United Arab Emirates presided over the meeting.

•A high-level open debate on **Threats to international peace and security** (13 June), focused on climate change, peace and security (S/2023/408). The Minister of Climate Change and Environment of the United Arab Emirates presided over the meeting.

•A high-level briefing on **Maintenance of international peace and security** (14 June), focused on the values of human fraternity in promoting and sustaining peace (S/2023/417). The Minister of State of the United Arab Emirates presided over the meeting and the Secretary-General provided a briefing.

Key Topics

Ukraine (6, 15, 23, 27 and 29 June), the Middle East (6, 12, 15, and 29 June), Sudan and South Sudan (2, 15, 20 and 23 June), Mali (7, 16 and 30 June) and Somalia (15, 22 and 27 June) were the most frequently considered country- or region-specific items in open and closed discussions.

Other country- or region-specific items considered by the Council included: Afghanistan, the Central African region, the Central African Republic, the Democratic Republic of the Congo, Libya and the Middle East, including the Palestinian question, Non-proliferation/DPRK and Peace and security in Africa. Under other matters (AOB), Council members discussed the Nord Stream gas pipeline incident and the situation in the Middle East, including the Palestinian question.

In addition to the signature events, Council members also held thematic meetings on **Threats to** international peace and security (UNITAD) and the International Residual Mechanism for Criminal Tribunals.

Procedural notes

On 6 June, **Algeria**, **Guyana**, **the Republic of Korea**, **Sierra Leone** and **Slovenia** were elected by the General Assembly to serve on the Council for a two-year term, starting in January 2024.

On 22 June, the Council held an **informal interactive dialogue** further to paragraph 6 of resolution 2672 (2023) concerning the humanitarian situation in **Syria**. This was the sixth **informal interactive dialogue** since resolution 2642 (2022), which introduced this format for the first time.

On 27 June, the **Informal Working Group on Documentation and other Procedural Questions** (IWG) held its third meeting of the year, chaired by Albania.

On 30 June, the General Assembly held a **debate on the Annual Report of the Security Council** (A/77/2) presented by the President of the Security Council (A/77/PV.86 and A/77/PV.87).

Decisions and press statements

In June 2023, the Council adopted **seven resolutions** (except for one, all resolutions were adopted unanimously). The Council did not issue any **presidential statement** during the month.

On 2 June, the Council adopted with one abstention resolution 2684 (2023), under Chapter VII of the Charter, extending for 12 months the **authorizations related to the Libya arms embargo** (see S/PV.9335). On the same day, the Council adopted resolution 2685 (2023), extending the mandate of **UNITAMS** for six months until 3 December 2023. On 14 June, the Council adopted resolution 2686 (2023), by which it urged States and international and regional organizations to **publicly condemn violence, hate speech and extremism**, and encouraged all relevant stakeholders to develop and share good practices to **promote tolerance and peaceful coexistence**. On 27 June, the Council adopted two resolution 2688 (2023), renewing **the sanctions regime in the Democratic Republic of the Congo** for one year and extending until 1 August 2024 **the mandate of the Group of Experts overseeing its implementation**. On 29 June, the Council adopted resolution 2690 (2023), under Chapter VII, deciding to terminate the mandate of **MINUSMA** and begin the drawdown and withdrawal of the mission with a view to completing the process by 31 December 2023.

The Council issued five press statements on the following topics: the ongoing **military clashes in Sudan** (SC/15305), the ongoing violence in Laascaanood in Somalia (SC/15313), the terrorist attack on ATMIS (SC/15314), the attack against MINUSMA (SC/15316), and the attack on an IDP camp in the Democratic Republic of the Congo (SC/15319).

Other activities

Council members convened one Arria-formula meeting on the topic: "Enhancing the Capacities of Member States to Ensure a Gender Responsive Approach to Counter-Terrorism" (26 June), organized by Malta and co-sponsored by Costa Rica, Jordan, Mexico, Mozambique, New Zealand, and Spain.
